GMO, VACCINES & PHARMACEUTICAL DRUGS

PART 3

A Report by John S. Torell

MEETING IN THE WHITE HOUSE

In 1986, Vice President George Bush met with a group of executives from the Monsanto Corporation in a special White House strategy meeting. There are no official records of the meeting, but Claire Hope Cummings, a former U.S. Department of Agriculture official revealed that the meeting was all about “deregulation” of the emerging biotech industry. These proposed deregulation plans were implemented in 1988 when Bush became president of the United States. At that time Vice President Dan Quayle was in charge of Bush’s “Council on Competitiveness,” and on



May 26, 1992, Quayle revealed the new policy on bioengineered food. At a press conference Quayle made the following statement: *“The reforms we announce today will speed up and simplify the process of bringing better agricultural products, developed through biotech, to consumers, food processors and farmers. We will ensure that biotech products will receive the same oversight as other products, instead of being hampered by unnecessary regulation.”*¹

Monsanto, Novartis and other corporations lobbied hard for no regulation and President Bush complied with their demands that genetically engineered plants, foods or animals were merely a simple extension of traditional animal or plant breeding. This is the reason that when you go shopping today for food there are very few labels which state the food product is a genetically modified organism (GMO). Interestingly, the people in South Korea took to the



streets in 2008, to demonstrate against the import of American beef. The reason was never explained in the American media but the Koreans simply did not want GMO beef. Are the Korean people smarter than the American people?

The Bush administration declared that the following agencies were qualified to oversee the GMO development:

- ❖ U.S. Department of Agriculture (USDA)
- ❖ Environmental Protection Agency (EPA)
- ❖ Food and Drug Administration (FDA)
- ❖ National Institutes of Health (NIH)

By giving oversight to these different agencies, the end result was no oversight at all. Independent researchers and scientists voiced the danger of DNA research and biotechnology with viruses, but their concerns were blown off by the different presidential administrations which took the position that the biotech industry was able to police itself. The result has been disastrous; for example, the development and production of vaccines that have given birth to an epidemic of autistic children in the world.

It is noteworthy to mention that the Rockefeller Foundation has plowed in millions of dollars to researchers working on biotech products. It should not come as a surprise since this foundation is part of the financing arm of the World Government.

President Bush made another fatal decision in 1992 when he issued an executive order² that GMO plants and foods were substantially the equivalent to ordinary plants of the same variety, such as ordinary corn, soybeans, rice and cotton.³ President Bush’s executive order gave the biotech corporations the legal footing that their modified plants and animals should and would be considered equal to normal crops and animals and therefore wouldn’t need regulatory measures.

When William Engdahl wrote his book “Seeds of Destruction,” he made the statement that President Bush issued an executive order but did not furnish the official number of that order. In my own research I could not find any place where such an executive order existed. In order to clear this matter up, I wrote the following message to

the organization handling Mr. Engdahl's written material on December 29, 2008:

We are the publisher of a monthly newsletter, The Flaming Sword and we have just written an article based on William Engdahl's book "Seeds of Destruction." On page seven in this book, Mr. Engdahl states that President George H.W. Bush issued an executive order in 1992 concerning GMO plants and foods. Researching this we found that no one has listed the number of this executive order and checking the White House records, there is no such executive order regarding GMO. Is it possible that this executive order has been "sanitized" and does not exist anymore?

I was pleasantly surprised when in less than 24 hours I received a response from Mr. Engdahl, confirming my suspicion that all records of this executive order have been destroyed.

"I have also been stymied in finding a paper trail to the mentioned Bush Sr. Executive Order. However, the doctrine is firmly entrenched so the chain of causality is there in some form for a decision that major. If your research finally finds a document, please let me know as others would appreciate as well. It may be that it came from the Bush White House (Monsanto) via OECD back to US Government agencies as suggested below. More I unfortunately cannot add at this time..."

The genetic modification of a plant or organism involves taking foreign genes and adding them to a plant such as cotton or soybeans to alter their genetic makeup in ways not possible through ordinary plant reproduction. GMO engineering is different from the old way of plant grafting and animal breeding. Genes from one species can be extracted and recombined with those of another species, using recombinant DNA. For example, it is very common that human cells are spliced with genes from mice to create a whole new living organism. This violates the creation order of God, who made sure that different species could not mingle with one another. The end result is unpredictable and creates "monster creatures" that become uncontrollable. Two examples are the "super viruses" and "super bacteria" for which there is no cure or antidote.

The horrible truth is that the executive order by President Bush exempted all biotech products from testing and automatically certified them as safe for human

consumption. Biotech is unregulated and no one knows for sure what the long term outlook will be for the consumer who is eating this concoction.

WHAT HAVE THEY DONE TO OUR MILK?

On November 5, 1993, the Food and Drug Administration (FDA) declared rBGH "safe" for use in milk cows, and the following month Monsanto, the chemical company, began selling its version of the drug to dairy farmers in the United States.⁴

At that time I considered myself on the cutting edge of World Government activities but I never heard of rBGH until 2007. For the past 14 years, together with the majority of the American people, I happily drank my milk, blissfully unaware if the dairy producing the milk used rBGH or not. There are milk dairies that do not use any GMO's or rBGH in their cattle but only use green pastures and unmodified natural feed.

For years, the people behind the GMO's have tried to eliminate raw milk from the market but a few brave dairymen have been able to stay in business through public demand for raw milk. Raw milk is unpasteurized and not homogenized and just like the milk that comes out of the cow.

BOVINE GROWTH HORMONE, A.K.A RBGH

This genetically engineered artificial hormone is called "recombinant bovine growth hormone" and is also known by its abbreviation of rBGH or rBST. It was the pharmaceutical giant Monsanto that began researching and then developing this genetically modified hormone for cows in 1984. By 1993 Monsanto had spent \$300 million before they had a drug that would work. The projected income for Monsanto at that time was around \$300 million per year in the United States and around one billion dollars annually in the rest of the world.

The president of the United States at that time was Bill Clinton and he was pushing hard for the U.S. agriculture industry to be dominant on the world market and some 60

genetically engineered food products were in the process of being approved by the FDA.

Monsanto and the Clinton administration had a cozy relationship and the president was counting on strong economic growth through GMO products, which would help him to win a second term in office. There was never a concern about the safety of the American people.



Monsanto's trade name for its growth hormone was "Posilac." The salesmen from Monsanto fanned out to the dairy farmers in the United States and told the farmers, that if they used this product, their cows would increase their milk production by 30%. In their advertisement they stated that no cow should be left untreated. Monsanto recommended that cows should be injected every two weeks in order to reach maximum milk output.

This growth hormone stimulated the cow to produce more milk, but the side effect was an increased production of another hormone known as IGF1, which regulates the cow's metabolism so that the cell division in the cow increased and hindered natural cell death. Different independent scientists spoke out, warning that Posilac increased the level of insulin-like growth factors, and had a possible link to cancer. Dr. Samuel Epstein, from the University of Illinois, School for Public Health, warned that IGF1 was linked to the creation of human cancer, but that it might take years before it becomes fatal in a human body.⁵

Once rBGH had been on the market for some time, farmers began to complain that their cows burned out some two years earlier than cows not on it. Furthermore, a number of cows began to develop serious hoof or udder infection as a result of the growth hormone.

According to a report from Rachel's Environment & Health News, I quote the following:

"...Unfortunately, a considerable body of scientific evidence from the U.S., England and Europe indicates that Commissioner Kessler is simply not telling the whole truth.

Substantial evidence indicates that milk from rBGH-treated cows is very likely to feature:

- ❖ *more pus from infected cows' udders;*
- ❖ *more antibiotics given to cows to treat those infections;*
- ❖ *an "off" taste and shortened shelf life, because of the pus;*
- ❖ *perhaps higher fat content and lower protein content;*
- ❖ *more of tumor-promoting chemical called IGF-I, which has been implicated in cancers of the colon, smooth muscle, and breasts.*

In return for accepting increased pus, more antibiotics, and tumor promoting chemicals in their glass of milk, what benefit will consumers get? None at all. Zero. Even FDA says there are no consumer benefits. In fact, because the U.S. already produces a surplus of milk, which is purchased by Uncle Sam, increasing milk production with rBGH will COST the taxpayer an additional \$200 million or more each year, estimates Consumers' Union. That's family money pumped into some chemical company's pocket. That's who benefits."⁶

Interestingly, FDA Commissioner David A. Kessler was appointed by President George H.W. Bush and retained by President Clinton. It really doesn't matter what political party is in office, the players are still the same.



MONSANTO IS A RUTHLESS CORPORATION

The executive leadership of Monsanto knew from the very beginning that there would be resistance from the American people in buying milk treated with rBGH. People working at the FDA were wined and dined by agents from Monsanto and the FDA ultimately decided that there was no need to label milk from cows treated with rBGH. But when certain grocery chains tried to label rBGH milk, Monsanto sued them in court. Not all courts agreed with the lawyers from Monsanto and eventually grocery chains like Kroger, Wal-Mart, Safeway and Publix switched their store brands of milk to certified rBGH-free milk.

By 2002, the figures given by the USDA showed that rBGH was given to 22% of the American milk cows, but in

2007 only 17% of the milk cows were given Monsanto's "cancer causing" growth hormone.⁷

SUPPRESSING EVIDENCE

In the late 1980's Monsanto provided the University of Vermont with a grant of over half a million dollars to run a series of tests to find out if there was any evidence of health problems with cows subjected to rBGH treatment. The testing showed that there was a widespread inflammation of the udders in the cows and birth defects to the offspring of these cows. The test results were leaked to the press by one of the scientists working on the project and ignited a firestorm from Monsanto who had released a number of statements from the lead scientist that rBGH was safe with no health problems.

The leak triggered an investigation by the U.S. General Accounting Office (GAO), an investigative arm of Congress. There was no cooperation from the University of Vermont or Monsanto; on the contrary, they did everything possible to sabotage the investigation. With no data shared, the GAO was forced to drop the investigation. The irony is that some years later the University released its findings of severe problems with the cows, but by that time it was too late, as thousands of people had been stricken with different illnesses from contaminated milk.

INCREASED LEVELS OF ANTIBIOTICS

It was in 1991 that the FDA created the new position of Deputy Commissioner for Policy to oversee agency policy on GMO foods. The general public, including myself, had no clue what this meant and who would be in charge of this new department. It is true what the Word of God says, that people perish because of lack of knowledge.

"My people are destroyed for lack of knowledge: because thou hast rejected knowledge, I will also reject thee, that thou shalt be no priest to me: seeing thou hast forgotten the law of thy God, I will also forget thy children." (Hosea 4:6)

The first man to hold this position was Michael R. Taylor, a Washington D.C. lawyer. He had previously worked for the law firm, King & Spalding, which had

specialized in drug laws and represented Monsanto and other biotech companies in regulatory cases.⁸ Margaret Miller, Monsanto's chief scientist, was another person from the biotech industry given a top job in the FDA as Deputy Director of Human Food Safety in the beginning of 1990. Thus, the biotech industry had two moles working in the agency that was created to protect the American people from dangerous foods.

Miller used her position to raise the FDA standard by 100 times for the permissible level of antibiotics that farmers could put into the milk. Simply put, since the rBGH hormone increased infections in the cows, farmers also had to increase the dosage of antibiotic to fight the infections. Unless Miller had raised the standard for antibiotics in the milk, farmers would have been forced to stop using rBGH and that would have hit Monsanto hard in the pocketbook.

Monsanto and Miller didn't care that the antibiotics given to the cows would contaminate the milk, and when people would drink this milk, they would absorb the antibiotics and slowly destroy their immune system. When a person develops an infection, a medical doctor will prescribe antibiotics to fight the infection, but there is a time limit on the treatment. By continually drinking contaminated milk, the American people will continuously be fed antibiotics without having an infection. I have never seen a study of the effect of long term consumption of antibiotics but I believe that many diseases now ravaging people can be traced to Monsanto and its use of hormones and antibiotics.

Michael Taylor did his dirty work and directed the study for guidelines on how to handle GMO foods. He decided there was no need to let the American people know what kind of genetically modified food was being sold to them, thus, the food processing companies did not label their products as such. Since the early 1990's we have all been oblivious that we are eating GMO foods. As the cancer rate increases year after year, no one is admitting that this is possibly from contaminated milk and GMO foods.



As the rBGH contaminated milk started to flow out to the market place, the FDA ruled that this milk did not need

a special label and so the consumer didn't have a choice when buying milk. No one knew where the milk came from. In the meantime, cancer research is receiving millions of dollars from the government and private institutions, and is one of the fastest growing industries in the world.

DON'T TELL THE PEOPLE

Michael Taylor served his masters well; under his direction, the FDA ruled that risk-assessment information such as data on birth defects in cattle and humans who had been consuming GMO foods should not be released to the public but be labeled "confidential business information." It wouldn't be good for Monsanto and the rest of the biotech industry if the public became aware of the grotesque deformities in babies and animals fed GMO foods. When it was time for Taylor to leave the FDA, he was appointed by Monsanto to be their Vice President for Public Policy. He has been well rewarded on Earth but is facing a terrible judgment once he exits this planet.

When further testing was done with rBGH and given to rats, it caused leukemia and tumors in them. In order to protect Monsanto from financial damage, the Pure Food and Drug Act was amended to allow a product which tested positive to causing cancer in animals to be exempt from being labeled as "possible cancer causing." Instead of protecting the consumer, the FDA protected the drug companies from losing money.

FOOD FOR THOUGHT

Having been in the ministry since 1967, I started to notice that women in America had begun to change. When I lived in Sweden women never had "hairy legs." But I noticed that the advertisement after the 1990's catered a lot to women, to buy razors to shave their legs. Then I noticed that women from their 40's and up started to sport mustaches and that a new line of products were offered to women, using hot wax to get rid of the hair growing over their upper lips.

Is it possible that drinking contaminated milk containing huge amount of growth hormone over a period of time is changing the make-up of the human body? Is it possible that boys and girls who drank hormone laced milk

during their childhood years, messed with their hormone system and they are getting confused and turning into homosexuals?

WHITE HOUSE CORRUPTION

During the Clinton presidency, Monsanto wanted the U.S. government to put pressure on the Canadian and Mexican governments to allow the sale of rBGH to the farmers in these two nations. But in 1999, the Canadian government rebuffed President Clinton and refused to allow growth hormones to be given to Canadian cows. Later, rBGH was banned in Japan, Australia, New Zealand and all the countries making up the European Union (EU).

MONSANTO'S DIRTY LAUNDRY

In 1997, Steve Wilson and Jane Akre, two investigative journalists working for FOX television (owned by the Australian Jew Rupert Murdoch) decided to do a story on the rBGH scandal and put the spotlight on Monsanto. Once the corporation officers of Monsanto found out about the documentary, pressure was put on Murdoch to kill the report and not air it. Not only did Murdoch's underlings make sure the videos were destroyed but Wilson and Akre were also fired. They filed a lawsuit against Fox that they had wrongly been fired and were awarded \$425,000 in damages. The court said that Fox acted intentionally and deliberately to falsify or distort the plaintiffs' news reporting on rBGH.⁹



Monsanto and Fox have in-house attorneys who get paid whether they are working on a case or not, the case was appealed to a higher court, which found "a legal technical mistake" in the proceedings in the lower court and ordered the verdict void. Fox then filed a counter-suit in 2004 for \$1.7 million to recover trial fees and costs.

Since the FDA was controlled by Monsanto and other pharmaceutical corporations, there was no follow-up by the federal government. It was business as usual while the American people were fed antibiotics and a toxic hormone in their milk.

PRESSURE BUILDS ON MONSANTO

FDA inspectors finally stopped bowing down to Monsanto and reported that they had found unacceptable levels of contamination in rBGH. Monsanto responded that it would cut its production of rBGH by 50% and the FDA inspectors and people in the milk industry thought that Monsanto would quietly stop production on its hormone drug. But in 2005, Monsanto announced that it was going to boost its production of rBGH to 70% of its original peak production.

Three years later, in August 2008, the Monsanto Board of Directors decided that the company could no longer take the bad publicity by continuing to produce and sell rBGH. It was not only looking at the bad publicity, but also the resistance from farmers to continue buying the hormone drug. On August 8, 2008, the giant pharmaceutical company Eli Lilly purchased the patent to rBGH and the right to produce and sell it.

Before Monsanto gave up on its poisonous hormone drug, it was busy pressing State governments in 2006 and 2007 to limit the use of “artificial hormone free” labels in its effort to deny the American people the right to know what is in their milk and other milk products like cheese. Monsanto was taken to court in Ohio for its pressure tactics and did not fare well in this campaign without a single state supporting their effort.

It will take action by the American people if this hormone drug is going to be made obsolete in the United States. In November 2008, it was reported that the coffee chain, Starbucks, had decreased its use of milk laced with rBGH by 37%, but that means that the majority of the cream and milk used in their coffee is still contaminated with rBGH. Corporations only change their products, when people stop buying it; this is the weapon of the consumer.

CORRUPTION IN WASHINGTON D.C.

The pharmaceutical companies over the years have managed to place people from their industry in high ranking government positions. The agriculture secretary under George W. Bush’s term in the White House, Ann Veneman, (born 1949) has held jobs in the agriculture fields for the State of



California and the USDA. When she was appointed as Secretary of Agriculture on January 20, 2001, she had been sitting on the Board of Directors of Calgene, a biotech company formed in Davis, California in 1980. The company specialized in genetically engineering tomatoes, canola oil and cotton and was purchased in 1996 by Monsanto. On January 18, 2005, she was appointed executive director for United Nations Children’s Fund (UNICEF) and subsequently resigned her position as the Secretary of Agriculture on January 20, 2005. This UN organization is among a number of projects in charge of the vaccination of children in the world. Thus, the pharmaceutical industry still has an ally in Ann Veneman.

Donald Rumsfeld (born 1932) also has a strong tie to the pharmaceutical industry. He served as Secretary of Defense from January 20, 2001, to December 18, 2006. From 1977 to 1985, he was the CEO of G. D. Searle and Company, a pharmaceutical company founded in 1888. Rumsfeld was instrumental in selling this corporation to Monsanto in 1985 and it is reported that he earned \$12 million dollars on this sale. G.D. Searle’s best known product is the deadly sweetener, Aspartame. From 1997 to January 20, 2001, he was the chairman of Gilead Science, Inc., a California biotech firm, known for its product Tamiflu, which was a bestseller during the scare of the “bird flu epidemic.”



Some people are well aware of the Gulf War Syndrome which was caused by tainted vaccines. The anthrax vaccine has crippled many American service men and women, and despite the knowledge that Saddam was not going to use biological warfare agents, the American military command insisted that all the people sent to the war zone in and around Iraq be immunized. The pharmaceutical companies made a huge profit on the vaccine sold to the military. What role did Rumsfeld play in this?

Michael “Mickey” Kantor is a former U.S. Trade Representative under President Clinton who became a Monsanto board member when he left office.

Another board member of Monsanto is William D. Ruckelshaus, former head of the EPA under Presidents Nixon and Reagan.

Michael A. Friedman, M.D., once acting director of the FDA is senior vice-president of clinical affairs for Monsanto's pharmaceutical division, G. D. Searle.

Marcia Hale is a former assistant of intergovernmental affairs to President Clinton and now Monsanto's director of the United Kingdom's government affairs.

Linda J. Fisher, Monsanto's vice President of Public Affairs, was an administrator of the EPA's Office of Prevention, Pesticides, and Toxic Substances.

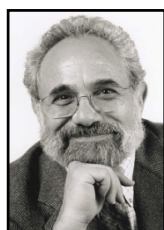
Jack Watson was the White House Chief of Staff during the Carter administration and now a Monsanto legal adviser.

WHO IS GIVING LEADERSHIP TO ALL OF THESE CORPORATIONS?

Monsanto, Dow Chemical and DuPont are the three leading corporations in the United States in genetically modified food and hormone treatment for livestock. They are not private corporations and do not have any "real owner." The stockholders in these companies do not set the policies unless a person is rich enough to buy up 51% of the stock and then would be in a position to dictate policies. Each corporation is run by Chief Executive Officer (CEO), who in turn is controlled by a Board of Directors.

The people running the World Government have been able to place people on the Board of Directors for the last 100 years who are willing to take orders and carry out

an agenda of a hierarchy that most do not understand. This is where the secret societies come into play.

LODGES AND FRATERNITY ORGANIZATIONS

Board members of these corporations in America are either professional, business, military or political persons. You will never find a blue collar worker sitting on as a board member.

All colleges and universities in the United States have fraternity organizations on their campuses. Some are co-ed but most of them are gender oriented. Recruitment is not done by advertising but through personal invitations. Only people deemed "pliable and gullible" are invited to join. Secret rituals, death oaths and secret communication skills are taught to the members and once they leave the school after graduation, they are still on the rolls and kept informed through newsletters and personal contacts as to what is going on and money is solicited to keep the fraternity organization going. George H.W. Bush as well as his son, George W. are both members of the Order of Skull and Bones, a Yale fraternity organization. Bush Sr. also held the post as director of the CIA from January 1976 to January 1977 which gave his handlers access to U.S. national secrets.

Graduates who are deemed as potential leaders in the World Government web of conspiracy are contacted by different lodges like Freemasons, Odd Fellows, Moose Lodge, Elk Lodge and invited to join. Again, the candidate is exposed to rituals which are increasingly satanic and occult. Powerful blood oaths are taken by the person which further deteriorating their moral values. Some rituals even demand homosexual acts. Adultery and fornication are common among the members of these lodges. There are degrees in the lodges and members are encouraged to study in order to advance. It is not cheap to be a member in a lodge and few poor people are members. Each member is kept under surveillance and those who look promising to the goals of the World Government are advanced more quickly.

It is from these cadres that people are being recommended as board members on corporations and candidates for political offices, judges, police chiefs, etc. Those who are considered very bright and pliable are invited to become members in the Council on Foreign Relations, the Trilateral Commission, the Bilderburgers and different foundations like the Rockefeller and Carnegie Foundations. Others are steered to positions in colleges, universities and seminaries in different denominations.

Once these people are placed in their life positions, they will implement the policies of their superiors. If they do well, they are rewarded, but if they do not perform



satisfactory, they are disgraced and fired. Eliot Spitzer is one such example. He is the former Governor of New York who was forced to resign on March 17, 2008. He is the son of a wealthy real estate investor and was educated at Princeton

University and Harvard Law School. He was a rising star in the Democratic Party and was doing well until he stepped on too many toes. As all other people of this caliber, he used "high class" expensive call girls (prostitutes). The word was given and the FBI was put on his trail and he was exposed. When it became big news, it put fear into all other members of the World Government network, *"I could be the next one being exposed, so I had best do a good job and keep my nose clean."*

There are hundreds of political, military and business people, as well as clergy, who have not done what they should have done, and been destroyed in the public press, while they were awaiting their court trials. The current scandal with the Governor Rod Blagojevich of Illinois is just another case in the long history of punishment for those who fall from grace with the World Government.



When we climb higher up on this pyramid of power, we come to organizations like The World Jewish Congress and the American Jewish Congress. Above them we find the World Zionist Federation and if we continue upward, there is the Council of 13. Since there haven't been any defectors from the Council of 13, we don't know what the very top looks like, but the Bible tells us that at the very top is Satan himself. Gentiles can rise to secret societies and the political organizations like the Council On Foreign Relations

but only Jews can advance to the top in this power pyramid.

ARE WE ANTI-SEMITIC?

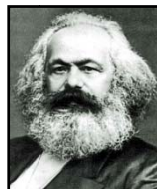

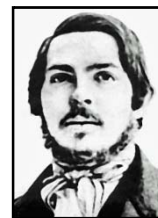

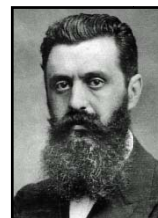

Most of them would be telling the truth because they really don't know. Each person is given just enough information to do their job. They do not necessarily know other people in the organization, only those who are in charge of them and giving the orders.

WHY IS THE WORLD GOVERNMENT INTERESTED IN GENETIC ENGINEERING?

The World Government has used its power to steer four American presidents to do its dirty work in destroying the natural seed supplies in the world, beginning with Ronald Reagan, then George H.W. Bush, Bill Clinton and George W. Bush. Instead of protecting the American people along with the grains and farm animals God created for man to have as food, the United States government, together with Monsanto, Dow Chemical and DuPont, have forced through the evil intentions of the World Government, so that the destruction of natural seed and farm animals is in full progress. Every year more and more of God's original creation is being destroyed and replaced with Satan's inferior products.

HOW THE TERMINATOR SEED IS PRODUCED

Corporations like Monsanto, Dow Chemical and Dupont contract with farmers in their employ to grow seed for them. Since terminator seed does not reproduce itself, there are two crops grown. Regular seed is planted and harvested for seeding purposes while the genetically modified grains which produce the terminator seed are sold to farmers around the world. These farmers plant the terminator seed and reap a crop which is used for food consumption. If the farmer tries to hold back a certain percentage of his yield for next year's crop, he will find that nothing grows from it. Thus he has to purchase new seeds every year.

THE RAPE OF THE IRAQI PEOPLE

When the United States invaded Iraq in 2003, the occupation was run by L. Paul Bremer, who in reality was a dictator whose word was law. Bremer is a former U.S. State Department terrorism official, who was later hired as the managing director of the consulting firm, "Kissinger Associates." This firm is headed by Henry Kissinger, a German born Jew and



former Secretary of State, a top player in the World Government for many years.



One of Bremer's edicts (Order 81) was that all Iraqi farmers were to stop using their ancient seeds for planting and instead use genetically modified seeds from the United States. Any farmer who did not obey this order was severely punished and had his crops destroyed.¹¹ This practice was not widely published in the United States, to the satisfaction of Monsanto and company, who garnered a monopoly on the market in Iraq, since they were paid for the genetically modified seeds by the American government, courtesy of the American taxpayers. Monsanto and company have been able to secure regulations from national governments over the years that it is illegal for farmers to use any other seed than those which are genetically modified. This is justified by stating that if normal seeds are used in an area where genetically modified crops are growing, the natural crop can have a damaging effect on the other.

ENTER AGAIN THE ROCKEFELLER FOUNDATION

On October 4, 1999, Gordon Conway, President of the Rockefeller Foundation, applauded the recent announcement by Monsanto that it had agreed to not "commercialize" its controversial terminator seed.¹² The Rockefeller Foundation has invested more than \$100 million for the advance of the GMO revolution. As I have stated earlier in this article, it is a financial arm of the World Government and financing for this global project of taking control over the food supplies in the world is a clear policy of the leadership in the World Government. These people operate on long term plans and are aware that the goals might never be met in their lifetime but their descendents will live to see it happen one day. The men (Adam Weishaupt, Mayer Amschel & Jacob Frank) that started this process of a World Government died some 300 years ago, but their project is alive and being pushed forward by their descendants.

Thus, the road has been opened for all the pharmaceutical corporations to use the technology developed by Monsanto and produce terminator seeds, which will dominate world-wide farming in the future.

SVALBARD GLOBAL SEED VAULT

Very few people know about the Svalbard seed vault. Since most people living on the earth today are very poorly educated (even if they have a college degree) they have learned very little about the role food plays in our global economy. Since you have read my article so far, you have been educated to the fact that food is a weapon and that the elite leaders in the world are working hard to secure the source of food.

According to National Geographic in an article dated December 7, 2007, there are about 1,400 seed banks in the world.¹³ Most of them are run by private corporations and serve as genetic repositories for a handful to several thousand different crop varieties.

The Svalbard vault in Norway has also been referred to as "the Doomsday Vault," that if global catastrophes like asteroid impacts or disease pandemics were to strike, seeds stored in the vault would ensure that humans could regrow the crops needed for survival.

It all began in 1984, about the same time the GMO research started to kick in high gear, the governments of Denmark, Finland, Iceland, Norway and Sweden had formed an organization, the Nordic Gene Bank (NGB), with each nation having the same number of representatives on its board of directors. This was a government sponsored organization using taxpayer money to develop a secure bank where grain and plant species from the nations could be stored in a secure place to prevent any loss of seeds and plants native to the Scandinavian countries.

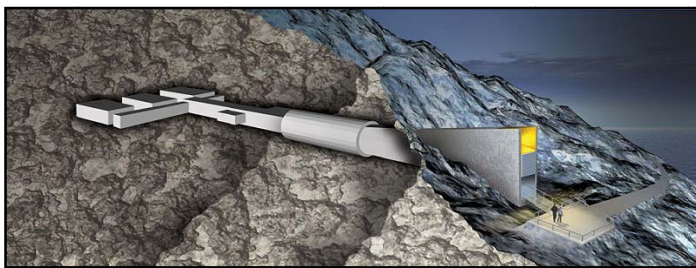
An abandoned coal mine at the Svalbard Island of Spitsbergen in Norway was used to store some 10,000 seed samples of more than 2,000 cultivars of 300 different species. After some time, seeds from South Africa were also sent to this coal mine for safe keeping. The World Government was involved in this project, working hard to

create a global seed bank, which would be easier to control than 1,400 scattered seed banks.



A new organization was formed, still sponsored by the Scandinavian countries, and the new name chosen was Nordic Genetic Resource Center (NORDGEN). The NGB was integrated into the new organization. This time the new seed bank would be housed in a specially built underground complex that was carved out from a mountain on the island of Spitsbergen. This project was not some kind of backwater project as was shown when the Prime Ministers of Denmark, Finland, Iceland, Norway and Sweden participated in the ceremonial construction start.



The underground complex is located 390 feet inside the mountain at a location of 430 feet above the ocean in order to make sure that even if all the ice melts on the earth, the complex will still be secure. Since the area is just 700 miles south of the North Pole, it is guaranteed that the temperature inside the vault is always below the freezing point. There are also coal mines on the island of Spitsbergen to provide ample fuel for the electrical power

plant generating electricity for the huge refrigeration units keeping the seeds 0 degrees Fahrenheit.

The seed vault officially opened on February 26, 2008. It is estimated that there are 1.5 million distinct varieties of seed in the world and the vault has the capacity to store 4.5 million varieties.

THE POLITICS OF THE VAULT

Officially, the government of Norway is the keeper of the vault. They own the vault but not the seeds deposited inside it. The seeds belong to the nations or corporations who have placed them there and samples can be withdrawn or deposited, just like money in a regular bank. Only the original depositor has the right to withdraw seeds from their account. This sounds good on the surface, but here is the truth: all the nations on the earth are “lured” to deposit their precious seeds into this global seed bank. One day in the future when the World Government takes control, all deposited seeds in the vault will be confiscated by its military forces. The future production of food is in their hands. Remember, food is a weapon.

REMEMBER PRESIDENT FRANKLIN D. ROOSEVELT

On April 5, 1933, the President Roosevelt issued a decree that all people living in the United States must surrender all gold coins (except rare coins), gold bullions and gold certificates to the nearest Federal Reserve Bank. Failure to do so could result in a \$10,000 fine and/or ten years imprisonment.



WHITE HOUSE OVERRULED FDA ON DRUG LAWSUITS

“FDA staff, White House disagreed on drug lawsuits,” was the headline in the Los Angeles Times on October 30, 2008, for an article that pointed out that President Bush and his White House staff rejected the claim of Diana Levine, a Vermont musician, who lost her arm to

amputation after she was injected with an anti-nausea drug, Phenergan, made by Wyeth.¹⁴

I have never heard of Wyeth before, and when I looked up this company, I found that it is one of the larger pharmaceutical companies in the United States. It was founded in 1860 by the Wyeth brothers and has developed into a behemoth. Its headquarters is located in Madison, New Jersey and it markets drugs which I recognize from advertisements on television. Over-the-counter drugs like Robitussin, Advil and Centrum; prescription drugs like Premarin and Effexor. These are just some of the more well known ones but there are hundreds of other drugs this company produces.

The warning label on Phenergan told doctors and nurses to use extreme caution when injecting the drug. If the needle struck an artery, it could cause gangrene. The warning label did not say Phenergan should not be injected because of the danger. Diane Levine sued Wyeth and alleged that the warning label was inadequate, and a jury awarded her \$6.7 million in damages. Wyeth appealed the verdict and urged the Supreme Court to rule that the FDA's approval of the drug and its warning labels bar lawsuits. The case was heard November 3, 2008, by the Supreme Court but no ruling has yet been forthcoming.

The sad and horrible thing is that President Bush has ordered the White House legal staff to join the attorneys for Wyeth and argue for a dismissal of the lawsuit and the jury award for Diane Levine. Here is a woman trusting the medical profession and ends up losing one of her arms, which means she cannot continue her life as a musician and then President Bush sides with the company who made the dangerous drug, leaving the woman without protection from her government. Diane Levine was seeking treatment for nausea and ended up losing an arm!

Governments can be trusted just about as far as a man is able to toss an elephant. It doesn't matter what country you look at, all elected officials in government services are paid to be liars and deceive the public. This is an historical fact; it is true today and it will be true in the future. Only men and women groomed by the World Government organizations are ever elected.

WHO PAID FOR THE VAULT?

You have heard this saying before, *"Follow the money trail and you will find the boss."* The cost of constructing this vault was estimated to be nine million dollars, which according to public records, was paid by Norway. Operating the vault will also be paid for by the Norwegian government and a special trust, the Global Crop Diversity Trust. The main donor for this trust is the Bill and Melinda Gates Foundation, who gave \$30 million. Few people know that Bill Gates is an American Jew and that he and his wife are giving away millions of dollars to New Age projects and environmental causes. When I started to look further into the Global Crop Diversity, I found out that this was a joint venture of the United Nations and a group known as Consultative Group on International Agriculture Research (CGIAR), which in turn was founded in 1968 with the help of the Rockefeller Foundation.

SUMMARY

As I have tried to sort things out and trace the leadership behind the destruction of our food, I find websites or books and the same players keep coming up again and again. It all leads back to the World Government and its intense labor to set up a world dictatorship. There is an old saying that, "all roads lead to Rome," which was true at the time of the Roman Empire but now it looks like "all roads lead to Jerusalem."

If you are a true born-again believer in Christ and reading from the King James Version of the Bible, you will find that God has spoken to us loud and clear as to what will happen in the future and who will be in charge of these events.

"Now we beseech you, brethren, by the coming of our Lord Jesus Christ, and by our gathering together unto him, That ye be not soon shaken in mind, or be troubled, neither by spirit, nor by word, nor by letter as from us, as that the day of Christ is at hand.

*Let no man deceive you by any means: for that day shall not come, except there come a falling away first, and that **man of sin be revealed, the son of perdition; Who opposeth and exalteth himself above all that is called God, or that is worshipped; so that he as God***

sitteth in the temple of God, shewing himself that he is God.” (2 Thessalonians 2:1-4)

The temple of God was first built by King Solomon in Jerusalem. It was destroyed and later rebuilt by people living in Judah, the Jews. This temple was also destroyed. The Jewish leaders have dreamed for centuries of rebuilding the temple, and since they now control Jerusalem, that dream will soon to come into reality.

And they worshipped the dragon which gave power unto the beast: and they worshipped the beast, saying, Who is like unto the beast? who is able to make war with him? And there was given unto him a mouth speaking great things and blasphemies; and power was given unto him to continue forty and two months. And he opened his mouth in blasphemy against God, to blaspheme his name, and his tabernacle, and them that dwell in heaven.

And it was given unto him to make war with the saints, and to overcome them: and power was given him over all kindreds, and tongues, and nations. And all that dwell upon the earth shall worship him, whose names are not written in the book of life of the Lamb slain from the foundation of the world. If any man have an ear, let him hear. He that leadeth into captivity shall go into captivity: he that killeth with the sword must be killed with the sword. Here is the patience and the faith of the saints.

And I beheld another beast coming up out of the earth; and he had two horns like a lamb, and he spake as a dragon. And he exerciseth all the power of the first beast before him, and causeth the earth and them which dwell therein to worship the first beast, whose deadly wound was healed. And he doeth great wonders, so that he maketh fire come down from

heaven on the earth in the sight of men, And deceiveth them that dwell on the earth by the means of those miracles which he had power to do in the sight of the beast; saying to them that dwell on the earth, that they should make an image to the beast, which had the wound by a sword, and did live. And he had power to give life unto the image of the beast, that the image of the beast should both speak, and cause that as many as would not worship the image of the beast should be killed.

And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads: And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name. Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.” (Revelation 13:1-18)

AS THE DAYS OF NOAH WERE

Jesus revealed a secret when he walked on this earth some 1,960 years ago when he said the following:

“But as the days of Noe were, so shall also the coming of the Son of man be. For as in the days that were before the flood they were eating and drinking, marrying and giving in marriage, until the day that Noe entered into the ark, And knew not until the flood came, and took them all away; so shall also the coming of the Son of man be.” (Matthew 24:37-39)

For many years I did not understand what Jesus meant with those words. The Greek word for sorcery in this passage of the Bible is “Pharmacia.” In reading my two previous articles, you should now have a clear understanding that Satan is using the pharmaceutical corporations to enslave the entire human population. First there were the recreational drugs like alcohol and opium. Then came the street drugs. The people who are not using recreational drugs or street drugs are made sick through genetically modified foods or by taking tainted vaccines. 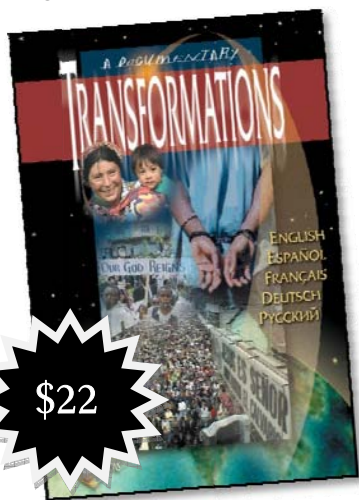

In solemnization reminiscent of the great celebratory spectacles of the Third Reich four million voices will be raised in adulation to the greatest con man to grace the political scene in the history of the nation, a seeming apparition without credentials who wandered onto the American political landscape ostensibly out of nowhere, and who has - along with his wife - expressed only a deep abiding disdain for the traditions and values of the Republic of which he is an unverified part. 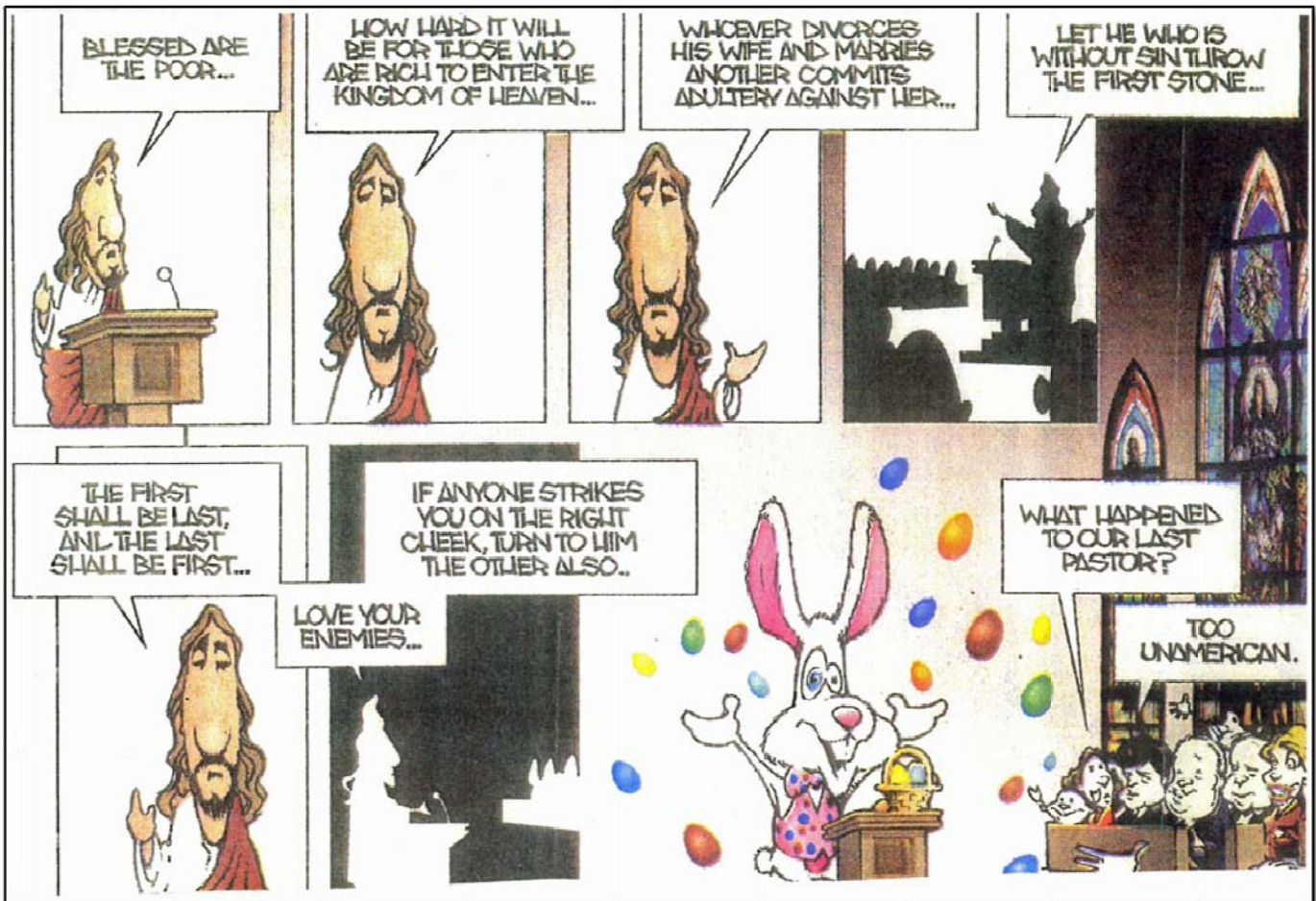

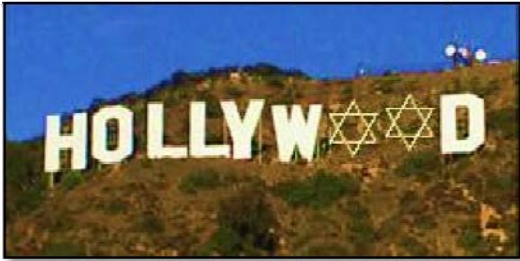

AMERICANS SUSPICIOUS OF BIG MEDIA, ADL DISTURBED

Abe Foxman, head of the Anti-Defamation League, is troubled. A recent ADL poll found that 61 percent of Americans believe their religious values are “under attack” by media. Fifty-nine percent believe those who run TV networks and major movie studios don’t share their religious or moral values. Forty-three percent believe there is actually “an organized campaign by Hollywood and the national media to weaken the influence of religious values in this country.” In addition, nearly 40 percent favor some kind of censorship of morally objectionable material in public places like libraries.

To Foxman, this is heresy. He says these erroneous beliefs come from people who “want to incorporate more religion in American life,” a Christian/conservative agenda ADL vehemently opposes. Foxman says ADL must calm these disturbing levels of suspicion.

“It is troubling that so many Americans feel as if the output of Hollywood is part of an organized campaign to undermine the religious values in this country,” he says. “It shows that in this age of pervasive media and the widening availability of the internet, many Americans still maintain a very parochial view towards the information age, and even believe in censorship to protect morality.”

But ADL’s poll also held good news for Foxman. In 1964, a similar ADL poll revealed nearly half of Americans believed Jews controlled Hollywood and big media. Today, only 22 percent believe this. This proves ADL has been powerfully persuasive in dispelling the “anti-Semitic canard” that Jews control media.

At least one person is not convinced.

In his recent *LA Times* column, “How Jewish is Hollywood,” Joel Stein objects: “I have never been so upset by a poll in my life. Only 22 percent of Americans now believe ‘the movie and television industries are pretty much run by Jews,’ down from nearly 50 percent in 1964. The Anti-Defamation League, which released the poll results last month, sees in these

numbers a victory against stereotyping. Actually, it just shows how dumb America has gotten: Jews totally run Hollywood.”¹

Stein lists Jewish media heads including: News Corp. president Peter Chernin; Paramount Pictures chairman Brad Grey; Walt Disney Co. chief exec Robert Iger; Sony Pictures chairman Michael Lyndon; Warner Bros. chairman Barry Meyer; CBS Corp. chief exec Leslie Moonves; MGM chairman Harry Sloan; and NBC-Universal chief exec Jeff Zucker.

(Some of the most famous stars in *front* of the camera are also Jewish, as a recent CBS2Chicago slideshow demonstrates.² Along with those more commonly known such as Billy Crystal and Steven Spielberg, famous Hollywood Jews include Harrison Ford, Adam Sandler, Michael Douglas, Sarah Michelle Gellar, the Gyllenhaals, Ben Kingsley, Kevin Kline, Kyra Sedgwick, Sean Penn, and many others.)

Stein writes, “The Jews are so dominant I had to scour the trades to come up with six Gentiles in high positions of entertainment companies. When I called them to talk about their incredible achievement, five of them refused to talk to me, apparently out of fear of insulting Jews. The sixth, AMC president Charles Collier, turned out to be Jewish.”

To find out why ADL distorts reality about Jewish media control, Stein called Foxman. The ADL head “said the number of people who think Jews run Hollywood is still too high.” Foxman told Stein, “That’s a very dangerous phrase, ‘Jews control Hollywood.’”

Curiously, Joel Stein thinks more Americans, not fewer, should know Jews dominate the flow of news, entertainment, and information in our society. If people knew the full Jewish contribution to America, he suggests, Jews would be praised and kept in control.

Stein concludes: “I don’t care if Americans think we’re running the news media, Hollywood, Wall Street, or the government. I just care that we get to keep running them.”

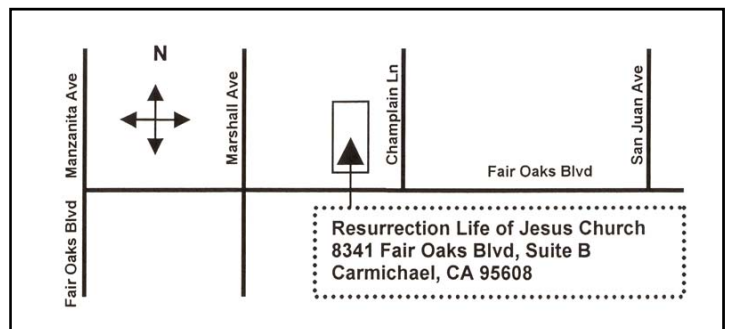

parents' concern changed to alarm as they watched him choose his own lonely and increasingly wicked path.

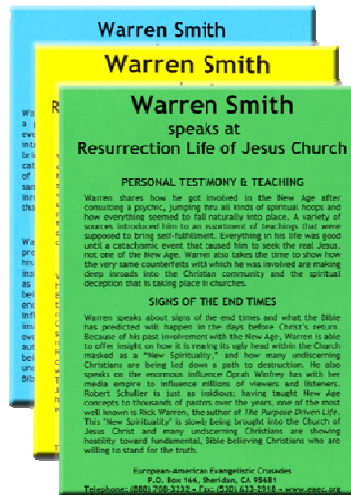

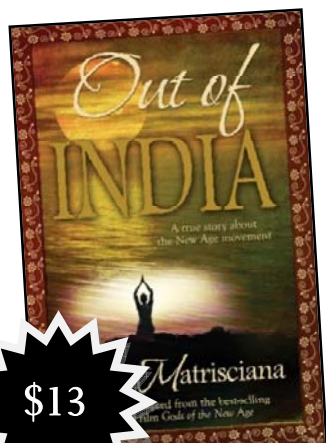
