# THE PERFECT MANCHURIAN CANDIDATE

During World War II, some American soldiers were captured in the Pacific and taken to the province of Manchuria (part of China) by the Japanese military command. There they were exposed to tremendous torture and brainwashing, also known as “mind control.” The Japanese were not the only ones engaged in this terrible crime against human beings. The Soviets and the Germans had their programs, so did the British at Tavistock and the Americans at Fort Dietrich, outside Washington D.C.

In 1945, when the war was over, certain groups within the American intelligence operation decided to bring as many German scientists, engineers and intelligence personnel as possible to the United States in a secret project known as “Operation Paper Clip.”<sup>1</sup> This program was run by a secret unit of the CIA and one of the goals was to perfect a program, where a person could be taken as a young child and then by splitting the young child’s personality into multiple personalities, a secret coded message could be planted deep within the brain that would be activated using certain memory triggers by the handlers. Captured enemy soldiers are also used in this kind of human abuse.

During my years as a pastor I have run across several people who had been exposed to this type of mind control and it was very hard to help them to be set free from the controls that were placed in them.

## DISINFORMATION FROM THE CIA

The people running the different intelligence services in the United States are well aware that secret operations taking place under the guise of “national security” will eventually be known by the American public. In order to combat this, they work with writers and movie producers in Hollywood. True information is given to the producers of books and script writers and they are told to write it like fiction. When books and movies are then released, people view it as fantasy and entertainment and the government can keep their dirty secrets.

In 1959, Richard Condon (right), a former sailor in the American Merchant Marines was working as a writer in Hollywood and his superior was an American Jew by the name of Max E. Youngstein.<sup>1</sup> Richard was given material concerning mind control, and in 1959 his book, “The Manchurian Candidate” was published. The plot was that an American army patrol had been captured during the Korean



War in 1952 and taken to Manchuria where they had been brainwashed. Once they were released secretly back into the American lines, they eventually wound up back in the U.S. The main character in later years ended up in a plot to take over the White House and turn the United States over to the Communists.

Another American Jew, George Axelrod, made a movie out of the book in 1962. The result is that the masses in America view this as fiction and will reject all information of what is going on in the real world. Amazingly, a new version of the film was made and released in 2004 with the same name. This time the main character emerged from “Desert Storm” in the Middle East, and again the handlers of the Manchurian Candidate were using him to capture the White House.

## ENTER BARACK HUSSEIN OBAMA

If you have not read my article, “The Obama Election Charade” you might have a hard time following the information I am about to give you.<sup>2</sup> I have documented that Obama was selected back in 1992 by American Jewish leaders in Chicago and for the next 16 years he was groomed for the presidency of the United States of America.

I want to point out to you that the Devil works through all kinds of people, regardless of their nationality. As I have written about and spoken many times, God selected Abraham and his seed to bring forth the Messiah so that all nations on the earth could be saved. Satan also selected Abraham’s seed to bring forth the Antichrist, and thus we are now seeing a Jewish World Government, better known as “the Zionist World Federation,” which is going to give the world a Messiah who in the Bible is also known as the “Son of Perdition.” (2 Thessalonians 2:1-12)

“A bastard shall not enter into the congregation of the LORD; even to his tenth generation shall he not enter into the congregation of the LORD.” (Deuteronomy 23:2)

Christians have not understood how strong a curse is and what kind of ramification it carries in the spirit world. When a person is conceived out of wedlock, there is a ten generation curse that will affect people for more than 700 years if we set the average life of a person to 70 years. As born again Christians, we have the legal spiritual right to break all curses, once we have repented of our sins. Most Christians never use this option to be set free from the curse and the demons that come with it.<sup>3</sup>

To people who are not born again believers in Christ what I am going to tell you will not make sense, but if you are a Bible believing Christian, it will make perfect sense.

## SATAN HAS A PLAN

The devil and his fallen angels used to live on planets in the universe until the devil decided that he was not content and wanted to unseat God and take over the creation. He was able to deceive one third of God’s angels to rebel with him. They created a war machine and started a war which they lost. (Revelation 12:7-17)

There was a trial at the end of the war and Satan and his fallen angels were sentenced to the Lake of Fire. The Devil appealed the sentence and it was put on hold and the Devil and his fallen angels were confined to the earth while God proved that He is a righteous God by creating man and allowing the Devil to have access to the human race. Thus, the war is being fought over control of the human race. In the end Satan is going to lose, but before he will lose this war, for a season he will gain control over the entire earth in a period which is called the “Great Tribulation.” (Matthew 24:21) The Devil will rule through people whom he has groomed from birth to do his work. The description of this period is found in the following Bible verses: 2 Thessalonians 2:1-13; Revelation 13:1-18.

## SELECTION OF A WOMAN THAT WOULD GIVE BIRTH TO A BASTARD

There have been millions of women who got pregnant and were not married from the time of Adam and Eve until now. But the woman the Devil was looking for at this time was to be rebellious toward God and not a Christian and into idolatry. The Devil had planned out the age of the Hippies, the flower children generation, the free love generation, and that young

people in America would abuse their own bodies and get high on the designer drugs the Devil had invented for them. The girl he selected was Stanley Ann Dunham, born on November 29, 1942. She was to be one of the flower girls in the Hippie movement.

## THIS IS NOT A CHARACTER ASSASSINATION

It is important that the reader understand that I am not trying to make this woman to look as bad as I can, I am simply going to share her background, the moral choices she made and her religious beliefs which had a bearing on her children.

## PARENTS

A child is shaped by the parents and Ann’s parents are responsible for her religious views. When Obama was running for president, he claimed that his grandparents on his mother’s side were either conservative Methodists or Baptists. Obama either spoke this in ignorance or lied since his grandparents, Stanley Dunham and Madelyn Payne were members of the Unitarian Church.<sup>ii</sup>

Stanley and Madelyn married on May 5, 1940 and settled in Wichita, Kansas. When the Japanese attacked the United States on December 7, 1941, Stanley joined the U.S. Army and Madelyn went to work at a Boeing plant in Wichita. At the end of World War II in 1945, the family moved around quite a bit, they left Wichita and moved to Ponca City, Oklahoma, then to Vernon in Texas and then back to El Dorado, Kansas. In 1955 the family moved to Seattle, Washington. All this moving meant that Ann changed schools each time they moved, which does not help a child to be secure because it uproots a person and makes them emotionally unstable.

It is interesting to note that when the family arrived in Seattle, the father worked as a furniture salesman and the mother held a job as vice president of a bank.

## THE CURSE OF THE FATHER

During my 39 years as a pastor I have found that when a parent forces something on a child, particularly if the parent thinks that the child has the wrong gender, it causes a lot of emotional damage and warps their personality. When Ann was born, her father was very disappointed since he wanted a boy. She was named “Stanley Ann” which was devastating for a girl to have a boy’s name. But her father’s name was Stanley and he wanted the child to be named after him. She was known by her first name Stanley and did not drop it until she was in college when she began to call herself “Ann.” According to her own comments, she was very embarrassed over

her name, which most likely created the rebelliousness that would surface once she began high school.

## SCHOOL YEARS

When the family arrived in Seattle, they lived in an apartment complex in the Wedgwood suburb. Apparently the parents were not happy with the Eckstein Junior High School, and in 1956 the family moved to Mercer Island, an eastside suburb of Seattle. She was 14 years old when she started to attend the brand new Mercer Island High School.

There were two teachers at this school who were to greatly influence Ann. Val Foubert (left) was an English literature teacher and Jim Wichterman was a philosophy teacher. Both men were heavily influenced by the “Frankfurt School philosophy” which originated in Frankfurt, Germany and consisted of a group of German Jews who wanted to make the theories of Karl Marx (communism) to work and so they developed powerful analyses of the changes in Western capitalist societies that occurred since the classical theory of Marx.



When Hitler and the Nazi party took over Germany in 1933, the school and the people associated with it moved to the United States. The philosophy of a Marxist system developed by the leaders of the Frankfurt School appealed to many young people in America, particularly after World War II, when many of the veterans came back to the United States and were deeply disillusioned.

To give the reader a historical background of how feelings were running among young people coming back from World War II, it is noteworthy that the motorcycle gang, “Hell’s Angels,” was formed by disgruntled young people. Val Foubert and Jim Wichterman opted to accept modified Marxism, and as two buddies teaching in a high school, they decided to do what they could to change the world by instructing high school students in their poisonous philosophy.

Between the two teachers, the students were learning rejection of societal norms, attacks on Christianity and the traditional family, etc. Students were assigned to read the works of Karl Marx, and Margaret Mead (right), an American cultural anthropologist who wrote on homosexuality and practiced it as well. Foubert and Wichterman produced a brood of liberal rebel rousing beatniks, the forerunners to the Hippie movement which was just a few years away at that time. Ann Dunham spent much time in the coffee shops in Seattle which were filled with young radical leftists. Even though she claimed to be an atheist, she continued to attend services at East Shore Unitarian Church, which was known for being a left-wing congregation.



## SUMMARY

When Ann Dunham graduated from high school, she was a dedicated radical leftist liberal and a strong feminist. During her high school years she never had a boyfriend and told people she had no need to date, marry and have children. Her teachers had succeeded beyond their wishes as Ann Dunham left high school a feminist and void of biblical morals, ready to go out and change the world. As far as she was concerned, Jesus was not God and just a man. Sin did not exist and she was governed by what was then called, “situation ethics” also known as, “Whatsoever is meaningful to you.”



## HAWAII

At the time of her graduation in 1960, her father had found work in Hawaii and insisted that Ann move with the family since she was not yet 18 years old. Ann enrolled at the University of Hawaii at Manoa and took a class teaching Russian, and it was here that she met an Islamic student from Kenya named Barack Obama, Sr.



## THE FIRST MARRIAGE

Ann got pregnant after she became sexually active with Barack. In the third month of her pregnancy, Barack and Ann married, February 2, 1961. But what he did not tell her was that as a good standing Muslim he was already married to a woman in Kenya (her name was Kezia) who had given her consent for him to marry a second wife. In time Barack Sr. told Ann about his first wife but claimed that he had divorced her which turned out to not be true. On August 4, 1961 at the age of 18, Ann gave birth to a boy which she named Barack Hussein Obama II.

## ONLY A CHRISTIAN WILL UNDERSTAND THIS

When Ann became sexually active with Barack Sr., she committed adultery since he was already married. (Exodus 20:14) Conceiving out of wedlock, she gave birth to a bastard who was cursed by God at the moment of conception. How seriously God looks upon adultery and the conception of a child in an adulterous setting is found in 2 Samuel chapters 11 and 12. King David took another man’s wife, made her pregnant, and when the child was born, David expected the child to be accepted by God. Instead, the prophet Nathan came and declared that the child must die, and God allowed the child to be struck with a disease so that it died within days. Why? God didn’t want a bastard becoming king after David’s death. The curse upon King David continued and has never stopped.

**“Wherefore hast thou despised the commandment of the LORD, to do evil in his sight? thou hast killed Uriah the Hittite with the sword, and hast taken his wife to be thy wife, and hast slain him with the sword of the children of Ammon. Now therefore the sword shall never depart from thine house; because thou hast despised me, and hast taken the wife of Uriah the Hittite to be thy wife. Thus saith the LORD, Behold, I will raise up evil against thee out of thine own house, and I will take thy wives before thine eyes, and give them unto thy neighbour, and he shall lie with thy wives in the sight of this sun. For thou didst it secretly: but I will do this thing before all Israel, and before the sun.”** (2 Samuel 12:9-12)

King David repented when he heard the judgment and was forgiven. (2 Samuel 12:13) But the consequences of his sin would plague his offspring, and when Solomon became king, he first reigned in righteousness but died a Satan worshipper (1 Kings 11:1-13), and his son caused the kingdom of Israel to be split (1 Kings 12:1-19), and it has been downhill since that time for the people of Israel.

**Ann Dunham Obama never repented of her adultery, she was not even a Christian and the curse upon her son was never removed. Barack Sr. was a Muslim belonging to a man-made religion that is cursed by God.**

## THE MYSTERY SURROUNDING BARACK OBAMA’S BIRTH

When Obama started to campaign for the presidency, calls started to come forward that he make his long form birth certificate public. These requests have consistently been rejected by Obama and his staff. The founders of the United States of America enacted a law that only a person born in the United States can qualify to become president of the United States. So on August 8, 2008, a lawsuit was filed in the U.S. District Court for the Eastern District of Pennsylvania by attorney Philip J. Berg, Esquire against Barack Hussein Obama demanding that Obama produce proof that he is a natural born citizen. This lawsuit has been resisted and still has not been resolved as of August 2009.



According to the factual allegations presented in this lawsuit, which are corroborated from a number of other sources, Obama Sr. and his second wife Ann Dunham traveled to Kenya to visit his family. This trip is supposed to have taken place sometime during the month of July, 1961 when Ann was close to giving birth. She was hindered from returning on a flight to the United States because the airline did not want a pregnant woman just

about to give birth on the airplane. Thus Barack Obama Jr. was born in Kenya on August 4, 1961. A few days later the couple and their newborn boy were able to fly out of Kenya, and upon return to Hawaii, Ann “registered” the birth of her son, but in the registration it doesn’t say where he was born.

Federal laws at that time stated that if a child was born abroad, and one of the parents was an American citizen, the parent must have lived for ten years in the U.S., of which five had to be after the age of 14. Ann did not qualify since she only had lived in the United States four years after her 14<sup>th</sup> birthday when she gave birth. Furthermore, if Obama Jr. would have been born in Kenya, his father was a citizen of Kenya and that would have made junior an automatic citizen of that nation or the British Commonwealth which was over Kenya at that time.

After this first lawsuit was filed by Berg, 17 more were filed in courts across the United States. All were vigorously fought by the United States Justice Department. According to Gary Kreep of the United States Justice Foundation, the Obama campaign spent \$950,000 from campaign funds to fight all the lawsuits filed against Obama. Eleven law firms in 12 states made sure that all possible news about Obama Jr. not being a natural born citizen was kept from the American public during the campaign.



The United States Constitution in Article II specifically states that no one can become the president of the United States except he is a natural born citizen.

**No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any Person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States.**

## THE CHILDHOOD OF OBAMA JR.

Sometime after Obama Jr. had been born, Obama Sr. decided to leave Hawaii and move to Massachusetts where he planned to enroll at Harvard University the fall of 1962. Ann left Hawaii and traveled to the state of Washington where she wanted her old friends to see the baby. She gave the impression that she was going to join Obama Sr. in Massachusetts but instead enrolled herself at the University of Washington in 1962 and lived as a single mother in the Capitol Hill neighborhood of Seattle.

While Obama Sr. continued to live in Massachusetts, Ann and their son moved back to Hawaii. In 1964 she filed for an uncontested divorce. She enrolled at the University of Hawaii and graduated in 1967 with a bachelor’s degree. Her ex-husband

graduated from Harvard with a master's degree in economics in 1965 and moved back to Kenya where he obtained a position with the Kenyan government. Obama Sr. died in 1982 through an automobile accident. For some reason that is unknown, Ann went back to Kenya for a visit after her ex-husband's death.

## OBAMA JR. BECOMES A MUSLIM

Some two years after her divorce, Ann met another foreign man. Lolo Soetoro (1935-1987) was from Indonesia and they were married in 1966. Lolo was an Indonesian oil manager and a devout Muslim. Once Ann had received her degree from the university in 1967, she moved with her new husband and Obama Jr. to Jakarta, Indonesia, with a population of 8.5 million people in the capitol. Lolo got a job as a government relations consultant with the giant American oil corporation, Mobile Oil. On August 5, 1970, Lolo and Ann had a daughter, which they named Maya Cassandra Soetoro. There comes another twist to the Obama saga, Obama Jr. had his name changed to "Barry Soetoro," and was enrolled in a public school in Jakarta, the Fransiskus Assisi School.

According to public records from the school which were filed in the lawsuit by Philip Berg, Barry was listed as an Indonesian citizen and his religion was Islam. His father was listed as Lolo Soetoro and his birth and place of birth were listed as August 4, 1961 in Honolulu, Hawaii. For the next four years Barry was educated as a Muslim.

## BARRY SOETORO RETURNS TO HAWAII

When Obama Jr. was ten years old in 1971, Ann decided to send him back to Hawaii to receive an American education. His grandmother was the vice-president of the Bank of Hawaii and paid his tuition at the expensive private Punahou Academy and also secured a scholarship too. Everybody called him Barry and he lived with his grandparents who were well-off financially so his claim that he comes from a poor background is not true. Barry started at the Punahou Academy as a fifth grader and continued until he graduated from high school in 1979.

According to Obama, he met his biological father only once in 1971. I don't know where this took place.

In 1972, Ann left Lolo and moved back to Hawaii with Maya. She enrolled again in the University of Hawaii as a graduate student for a Ph.D. in anthropology. From time to time she would return to Indonesia for her fieldwork and saw her estranged husband during these trips. They were divorced in 1980 and Lolo died in 1987.



## OBAMA'S COLLEGE YEARS

During the month of April, 2009, some astonishing news was released concerning Obama's two years at Occidental College in Los Angeles where he enrolled in 1979. Americans for Freedom of Information released copies of Obama's college transcripts from this college showing that Obama had enrolled under the name Barry Soetoro and listed himself as a foreign student from Indonesia. As a "foreign student" he had applied for a scholarship from the Fulbright Foundation which only gives out scholarships to students who can prove their foreign citizenship.

**I have to conclude that Barry either lied about his citizenship or did not know what country was his.** But the following event proves that Barry was not lying about his citizenship when he traveled to Pakistan in 1981 using his Indonesian passport as a 20 year old man. Either he never had American citizenship or he had lost it. Regardless, according to his passport, Barry was not an American but an Indonesian.



Barry Obama never did graduate from Occidental College. Instead, he moved to New York after two years and attended Columbia University, and in 1983 he graduated with a degree in political science.

## OBAMA'S YEARS AFTER COLLEGE

After his graduation from Columbia, Barry worked one year for the Business International Corporation (founded in 1953 by Eldridge Haynes and his son) that catered to American businesses working on the international market, gathering business intelligence and then advising corporations what to do in the various nations where they operated.

From having worked in a profit-driven capitalist environment, Barry then switched over to the left social side of society and started to work for the New York Public Interest Research Group (NYPIRG), which is a non-profit organization geared to policy reforms while training students to become advocates.

Barry worked less than two years for NYPIRG and then went to Chicago, where he was hired by a Roman Catholic organization called, "Developing Communities Project" (DCP). It is interesting that a Catholic organization would hire a Muslim as its director. Originally the DCP consisted of eight Roman Catholic parishes on Chicago's far South Side. During Barry's three years as the director (Community Organizer) the staff grew from just him to 13 persons and its annual budget went from \$70,000 to \$400,000.

**At this time, there are questions to ask:**

1. What motivated Barry to leave Occidental college and go to Columbia?
2. After working only one year in a highly developed business driven corporation, why did he move to a non-profit organization bent on dismantling current systems in the United States?
3. Why would a board of directors of a Roman Catholic organization hire a Muslim to run their charity work?
4. Where did the money come from that increased the DCP budget 471%?
5. It is known that in 1992 wealthy Jewish people started to surround Barry and groom him for the presidency of the United States. Is it possible that Barry was recruited and groomed during his college years?

## THE RECRUITMENT OF OBAMA

A smoking gun is found in the Fulbright scholarship. For centuries the ruling elite have handpicked their future political, military, business and educational leaders at the college level. Since these people are not going to set policies, but carry them out, they are looking for men and women who are pliable, can be morally corrupted and have no strong Christian principles. A man addicted to sexual perversion, including fornication, adultery and homosexuality is highly coveted since this can be used to blackmail him in the future by exposing him publicly and taking him out of office.

## RHODES SCHOLARSHIP

The Rhodes scholarship is for men and women to study at the University of Oxford in England. It was established in 1902 by the Cecil John Rhodes' Trust. Cecil was a loyal player for the ruling elite as a businessman and politician. Born in England in 1853, he was sent as a teenager to Natal, South Africa, because of bad health. Here he established a farm together with his brother. In 1873, only 20 years old, he went back to England to finish his education at Oriel College in Oxford. While attending college he also joined the Freemasons and remained one until his death in 1902.

At the age of 18, Cecil became a protégé of the Rothschild family in London. He and his brother moved to the diamond fields of Kimberley in South Africa, and in time Cecil achieved a monopoly of the diamond mining under the DeBeers Mining Company which he co-founded in 1880. With Rothschild financing, Cecil was able to expand his enterprises while the Rothschild family made huge profits on the sale of the diamonds. Through stealth, lies and broken treaties, Cecil became the founder of



Rhodesia, and fought two wars with the native population before British troops were able to secure the land.

Cecil never married and there were persistent rumors that he was a homosexual. To show his mindset, I quote from his first will:

In his first will, of 1877, (before he had accumulated his wealth), Rhodes wanted to create a secret society that would bring the whole world under British rule. The exact wording of the will is:

“To and for the establishment, promotion and development of a Secret Society, the true aim and object whereof shall be for the extension of British rule throughout the world, the perfecting of a system of emigration from the United Kingdom, and of colonization by British subjects of all lands where the means of livelihood are attainable by energy, labour and enterprise, and especially the occupation by British settlers of the entire Continent of Africa, the Holy Land, the Valley of the Euphrates, the Islands of Cyprus and Candia, the whole of South America, the Islands of the Pacific not heretofore possessed by Great Britain, the whole of the Malay Archipelago, the seaboard of China and Japan, the ultimate recovery of the United States of America as an integral part of the British Empire, the inauguration of a system of Colonial representation in the Imperial Parliament which may tend to weld together the disjointed members of the Empire and, finally, the foundation of so great a Power as to render wars impossible, and promote the best interests of humanity.”<sup>4</sup>

Two of the most well known Rhodes Scholars are the late Senator J. William Fulbright and former president, Bill Clinton.

## FULBRIGHT SCHOLARSHIPS

William Fulbright (1905-1995) was a Democratic Senator from Arkansas and served in the Senate from 1944-1974. Two years after he had been elected to the Senate, this “rookie Senator” began to push legislation “Fostering leadership, learning and empathy between cultures.” For some unknown reason, Congress created a scholarship program in 1946 for foreign students to attend college in the United States, and in honor of Senator Fulbright, it was named the “Fulbright Fellowship.” The program is administered by the U.S. Department of State and funded by an annual appropriation from Congress. Hillary

Clinton is the current Secretary of State and has the final say on who will get a scholarship.

## FULBRIGHT TURNED ON HIS HANDLERS

During the 1973 senate election, Fulbright went public on CBS' "Face the Nation" on April 15<sup>th</sup> when he made this statement:

"Israel controls the United States Senate. Around 80% are completely in support of Israel; anything Israel wants it gets. Jewish influence in the House of Representatives is even greater."

At that time in his career as a Senator, Fulbright was a heavy player in American foreign politics. He had been appointed a member of the Senate Foreign Relations Committee in 1949 and served as its chairman from 1959 to 1974, the longest serving chairman in the history of that committee.

The Jewish American "attack dog," the Anti-Defamation League (ADL), led the attack against Fulbright, and Jewish money started to flow into the coffers of his democratic challenger, Governor Dale Bumpers. With Jewish money and the Jewish controlled media, Fulbright was defeated in his re-election bid. Every American politician knows that if you want to be elected to any office, you must be a supporter of all Jewish causes and particularly the State of Israel. Once the most powerful democratic senator in the United States, Fulbright was quickly put out to pasture and there was nothing he could do about it.



## INDOCTRINATION

With a Rhodes or Fulbright scholarship comes indoctrination and both Bill Clinton (left) and Barry Soetoro had to attend certain meetings and read required material in addition to their regular college studies. Therefore we can see the "unseen hand" guiding young Barry through college and through the different assignments he was given on his way to the highest office in the United States. Money is never an issue once you are in the cattle feed barns of the World Government making sure to follow the outlined program and not stepping on any toes of the people feeding you. Both Bill and Barry have been obedient and so far they have been well cared for. A battery of lawyers will take care of any legal problem that might show up, like the Monica Levinsky affair or not being born in America.



## THE GAMALIEL FOUNDATION

While Barry was working with the Catholic DCP he also got involved with another Chicago organization called the "Gamaliel Foundation." This was an organization founded by Saul David

Alinsky (1909-1972), who was born in Chicago to Russian Jewish immigrants. Again we must look at the founder of this organization to understand the kinds of values transferred to Barry. Alinsky attended the University of Chicago in 1926 where he majored in sociology but did not graduate. He became a Marxist and a radical looking for social revolutions. He wrote a book in 1971 entitled, "Rules for Radicals," in which he openly stated his disdain for the American system and the need to overthrow it. In the prologue, he outlined his strategy and gives us a telltale sign of where Barry Obama gets his value system:



"There's another reason for working inside the system. Dostoevski said that taking a new step is what people fear most. Any revolutionary change must be preceded by a passive, affirmative, non-challenging attitude toward change among the mass of our people. They must feel so frustrated, so defeated, so lost, so futureless in the prevailing system that they are willing to let go of the past and change the future. This acceptance is the reformation essential to any revolution. To bring on this reformation requires that the organizer work inside the system, among not only the middle class but the 40 per cent of American families - more than seventy million people - whose income ranged from \$5,000 to \$10,000 a year [in 1971]. They cannot be dismissed by labeling them blue collar or hard hat. They will not continue to be relatively passive and slightly challenging. If we fail to communicate with them, if we don't encourage them to form alliances with us, they will move to the right. Maybe they will anyway, but let's not let it happen by default."<sup>5</sup>

During the presidential campaign when Barry proudly announced that he had been a community organizer in Chicago, his political opponents mocked him and the American people laughed. What we didn't know is that a "community organizer" is a secret revolutionary bent on the destruction of the current system. After some six months in office as the president, we are no longer laughing as we realize there is a revolution happening that does not bode well for the United States of America.

## BARRY GETS RELIGIOUS

During his time as a community organizer Barry decided that he needed to join a church and selected the radical, "Trinity United Church of Christ," pastored by Jeremiah Wright. There is no record that Barry was born again and accepted Jesus as his Lord and Saviour, he simply

joined the church, and the Muslim now called himself a Christian.

## TIME TO TRAVEL

In the summer of 1988, Barry took time to travel and spent three weeks in Europe. From here he flew to Kenya where he spent five weeks, meeting with his father's relatives. This brings to mind two questions: what kind of passport did he travel with and where did he get the money for the trip? The answers to these questions have never been made public.

## BACK TO SCHOOL

Barry's handlers decided that it was time for the radical community organizer to get some more education so in 1988 he moved to Massachusetts to attend Harvard Law School. Harvard like so many other older universities is ruled by secret fraternities which in turn are sponsored by Freemason lodges. It didn't take long for Barry to get a high position, and in February, 1990, he was elected the first African-American editor of the Harvard Law Review.

It is a little confusing at this point when we ask questions like: Is Barry more black than white? Or is he more white than black? Is he an African-American or is he an Indonesian-American? The answer to these questions will vary depending upon what time we look at his life. Barry is truly a Manchurian Candidate.

In the summers Barry returned to Chicago where he worked as a summer associate at the law firms of Sidley & Austin in 1989 and for Hopkins & Sutter in 1990. There was a young woman fresh out of law school at Harvard working as an intern at Sidley & Austin who was assigned to be his advisor. Her name was Michelle Robinson and in time she would become Barry's wife.

Barry graduated in 1991 with a Juris Doctor (J.D.) magna cum laude (a Latin expression for specific grade or class rank). Barry was then promoted and a publishing house offered him a contract for a book on race relations but it became a personal memoir and the book was not published until 1995 under the title, "Dreams from My Father." Barry was given an advance for writing the book.

## BACK IN CHICAGO

Coming back to Chicago, Barry then got a job as a civil rights attorney working for the firm "Miner, Barnhill & Galland." This was at the height of Bill Clinton's presidential campaign in 1992. During the months from April to October, Barry directed "Illinois' Project Vote," a voter registration drive with a staff of ten paid full-time employees and some 700 volunteers. Their goal was to register 150,000 of the 400,000 unregistered black people living in the state and Barry was able to

have the group achieve its purpose. His handlers were doing a smooth job of getting their candidate educated in the right places and paying his dues to the Democratic Party. In the previous newsletter, I wrote the following:

"Obama was selected more than 16 years ago to be groomed for the presidential role. Since this write up is very limited in space, I cannot go into great details. But what I have found out is very troubling. It was during the 1992 voter-registration drive in Chicago, coordinated by Obama, that he was selected by the American Jewess Bettylu Saltzman (maiden name Klutznick). She acted as an agent for the Jewish political group in the Democratic Party, which was looking for future candidates to run for political offices, and directed the American Jew David Axelrod to start grooming this up-and-coming 30 year old attorney."<sup>6</sup>



## BARRY-THE PROFESSOR

Barry then put in 12 years as an educator, working as a professor of constitutional law at the University of Chicago Law School, first as a Lecturer from 1992-1996 and then as a Senior Lecturer from 1996-2004. One might think that a professor of constitutional law for twelve years should know that one of the legal requirements of becoming president of the United States is that you must be a natural born citizen.

## MICHELLE ROBINSON

When the World Government grooms a person for future use as a political leader, they take it very seriously whom they are to marry. Michelle has expressed herself that she felt some kind of an "intrigue" working at Austin & Sidley and being assigned as an advisor to a young intern like Barry. Looking at it from a management point of view, it would not be the best decision to assign a young lawyer fresh out of law school with very little experience at the law firm to train an intern. Most likely it was pre-planned and only Barry himself could tell what his handlers had told him about Michelle.



Michelle was born in 1964 and raised on Chicago's South Side. Her father, Frasier Robinson, was a city pump operator at the water plant, and her mother Marian worked as a secretary for the well-known catalog firm, Spiegel. As most black families at that time, they were members of the Democratic Party and Frasier was a precinct captain and part of the infamous Chicago

Democratic Machine. A label used at that time on people like Frasier would have been a “Yellow Dog Democrat,” meaning that if the party was running a yellow dog for an office, rank and file people would vote without hesitation for the yellow dog. At the time when their children were small, Marian was a stay home mom. Since they were a blue collar worker family, they would not have had the money to send first their son Craig and later Michelle to Princeton so there must have been scholarships or someone else paid the tuition and the cost of living.

Michelle attended Whitney M. Young Magnet High School, which was opened in 1975 and was located on the Near West Side of Chicago. It was a public school but very selective about its students and it offered a rigorous college prep curriculum to Chicago’s most academically advanced students. In 2005 the school was ranked among the top 10% of the high schools in the U.S. In the 2007-08 freshman class, 9,000 students applied for the 450 coveted openings.

Michelle must have been a hard working and talented student since she was on the honor roll for four years, took advanced placement classes, was a member of the National Honor Society and served as student council treasurer. Her commute time to and from the school was around three hours per day. It is interesting to note that one of her classmates was Sanita Jackson, the daughter of Jesse Jackson.

Michelle graduated from high school in 1981 and enrolled at Princeton University where she majored in sociology and minored in African American studies. She graduated from Princeton in 1985 with a Bachelor of Arts in sociology. Fresh out of college she enrolled at Harvard Law School and graduated in 1988 with a Juris Doctor (J.D.).

As I stated before, the schools that Michelle attended were not cheap and it would have been impossible for her to pay the cost unless there were scholarships or someone outside the family paid for this education. During the 2008 presidential campaign, written material about Michelle circulated on the Internet, complaining that this black American from a blue collar worker family in Chicago had benefitted to attend the finest schools in the United States while she actively participated in political demonstrations during her years at Harvard, demanding the hiring of more professors from minority groups.

Barry and Michelle dated for two years after meeting in 1989, and on October 18, 1992, they were married at the Trinity United Church of Christ where Rev. Jeremiah Wright



performed the ceremony. They have two children, Malia Ann (right) born 1998 and Natasha (left) born 2001. When Rev. Jeremiah Wright came under fierce criticism for his many statements against the United States and Jews during the presidential campaign in 2008, Barry made

a point to state that he had been in the church for some 20 years, he was married in the church, his daughters were baptized in the church, but he had never paid attention to the many inflammatory statements the pastor had made. However, in order to pacify American Jews and his handlers, Barry resigned as a member. Here is a statement by Barry in March 2008 during the campaign:

“I don’t think my church is actually particularly controversial... Rev. Wright is like an old uncle who says things I don’t always agree with, everyone has someone like that in their family.”

## THE FINAL GROOMING OF MICHELLE

Sometime after Michelle married Barry, she quit her job with the law firm and worked for the city of Chicago. She became an assistant to the powerful democratic mayor Richard M. Daley (right), who had been elected mayor in 1989. He was the son of the reputed Democratic Party boss Richard J. Daley, who had run Chicago for 21 years through the labor unions and the Mafia.



Michelle then transferred to the Planning and Development department where she served as an assistant commissioner. In 1993, Michelle left the city employment and went to work for the Chicago office of Public Allies (PA), a non-profit leadership-training program that helped young adults develop skills for future careers in the public sector on social issues (a grooming school). Barry had been a founding member of the board of directors of the PA, but resigned one year before his wife became the executive director in 1993. She kept this position for the next four years.

In 1996 Michelle was hired as the Associate Dean of Student Services at the University of Chicago. In 2002 she took the position of executive director for community affairs at the University of Chicago Hospitals. In May, 2005, she was appointed vice-president of community relations and external affairs at the University of Chicago Medical Center. Michelle also managed the business diversity program and is a board member on six different corporations, including the Chicago Council on Global Affairs, the University of Chicago Laboratory Schools and a salaried board member of TreeHouse Foods, Inc., which is one of the major suppliers for Wal-Mart. During the presidential campaign Michelle started to cut back on her different jobs.

The Obama’s are not poor people judging by their 2006 tax return. As a senator Barry had a salary of \$157,082. Michelle earned \$273,618 from her job at the University of Chicago Hospitals. She also earned \$51,200 as a board member of TreeHouse Foods. The Obama’s earned an additional \$509,396

from investments and royalties from Barry's books. Thus their total income during the year 2005 was \$991,296.

These kinds of financial figures are normal for prominent people in the Democratic Party who are not poor. Politicians may come into the party with little cash on their hands and receive lavish salaries, gifts and royalties or they are well to do from the beginning. An example of this would be Nancy Pelosi, the Speaker of the House of Representatives. According to public records in 2007, Nancy and her husband Paul reported a net worth of approximately \$19 million. Their wealth is in investments of a large portfolio of real estate in the San Francisco Bay Area, a vineyard in St. Helena, California valued at 5 to 25 million dollars. Paul also owns stock worth \$5 million in Apple Computer.



**A true Marxist-Socialist will always speak about helping the poor and needy while they build their own wealth. They expect and demand to live a life of luxury and lavish spending on themselves while they are taxing others to death. Barry and Michelle are true Marxist-Socialist's.**

## WHAT THE SPIN DOCTORS RELEASED

Image is everything for a political officeholder and the following information was released concerning Michelle: Michelle allegedly had initial reservations about her husband's presidential campaign due to fears about a possible negative effect on their daughters. She stated that she had negotiated an agreement in which her husband gave up smoking in exchange for her support of his decision to run for president. She also stated that she was not Barry's senior advisor. Michelle has been marketed as a successful professional businesswoman, having a steely, no-nonsense campaign style as well as a keen sense of fashion.

The American Jewish press has been very nice to her. In May 2006, she was featured in Essence Magazine as one of "25 of the world's most inspiring women." In September 2007 she was listed in O2138 Magazine as number 58 in the "Harvard 100" list of the most influential alumni for the year. Vanity Fair put her on the "best dressed women" list two years in a row and People Magazine put her on their "best dressed women" list in 2008.

America's "wag the dog television hosts" have also been very nice to her. In September 2008, she was a guest on the homosexual Ellen DeGeneres Show in which she stated that she and Barry did not intend to have any more children. Oprah Winfrey gave her two guest appearances during the 2008 campaign, as Oprah had come early out as a supporter for the Obama presidency. Larry King had her as a guest on October 6, 2008, and the same night she was also a guest on the Daily Show with Jon Stewart. Both of these men are American Jews.

It is interesting to note that on June 13, 2008, she was interviewed on the Fox News show "America's Pulse." (Fox is owned and managed by the Australian Jew Rupert Murdoch). The host was E.D. Hill (right), who referred to the "Marxist fist salute" that Barry and Michelle did in Minnesota when he had clinched the Democratic presidential nomination. The next day Hill was taken off the air and the show was cancelled and replaced with a different program. Again we can see the power of the Jewish world leaders and what happens if you rock the boat.



## BACK TO BARRY

As a good Marxist-Socialist, Barry has paid his dues. From 1994-2002 Barry served on the board of directors of the Woods Fund of Chicago<sup>iii</sup> and from 1994 to 2002 as a board member of the Joyce Foundation.<sup>iv</sup> From 1995 to 2002 Barry served on the board of directors of the Chicago Annenberg Challenge.<sup>v</sup> Barry was not only serving on the board of directors, he was the founding president and chairman of the board from 1995-1999. It was the Annenberg Foundation<sup>vi</sup> that stood behind this huge social change of the public schools in Chicago.

My reason for including the information on these different foundations is to show the strong Marxist-Socialist forces that tapped Barry to be part of this social engineering project to change the political and educational landscape in Chicago, a stronghold of the Democratic Party. It was the vast sums of American Jewish money that paved the way for social changes in Chicago, which was a dress rehearsal for what the World Government leaders want to do with our entire nation. It should not come as a surprise when we look back and find that Barry's slogan during his presidential campaign was "change."

## THE DEATH OF BARRY'S MOTHER

In 1994 Barry's mother Ann was diagnosed with ovarian and uterine cancer and moved back to Hawaii to live close to her widowed mother. She died in 1995 at the age of 52. Barry flew back to Hawaii, and following a memorial service at the University of Hawaii, Barry and his sister Maya spread the ashes of their mother in the Pacific Ocean on the south side of Oahu. When his grandmother Madelyn died in December 2008, Barry scattered her ashes in the same location.

Since Barry claims that his mother had a great influence on him as a person, it is important to find out a little bit more about her religious belief system. In December 2007, Barry was asked on MSNBC about his connection to Islam. Here is how he answered:

"My mother was a Christian from Kansas. I was raised by my mother so I have always been a Christian."

And in a speech in 2007 he said:

“My mother, whose parents were nonpracticing Baptists and Methodists, was one of the most spiritual souls I ever knew. But she had a healthy skepticism of religion as an institution.”

These are two blatant lies from Barry in these statements. As I have stated earlier, his grandparents were Unitarians, not Baptist or Methodists. Both Barry and his sister Maya Soetoro-Ng have stated on numerous occasions that their mother was not a Christian. Let me quote his sister’s statement as it has been listed on the biography of Ann Dunham on Wikipedia:

Maya Soetoro-Ng, when asked if her mother was an atheist, said, “I wouldn’t have called her an atheist. She was an agnostic. She basically gave us all the good books – the Bible, the Hindu Upanishads and the Taoist scripture, the Tao Te Ching, Sun Tzu - and wanted us to recognize that everyone has something beautiful to contribute. Jesus, she felt, was a wonderful example. But she felt that a lot of Christians behaved in un-Christian ways.”<sup>7</sup>

In his 1995 memoir, “Dreams from My Father,” he wrote:

“My mother’s confidence in needlepoint virtues depended on a faith I didn’t possess...In a land (Indonesia) where fatalism remained a necessary tool for enduring hardship...she was a lonely witness for secular humanism, a soldier for New Deal, Peace Corps, position-paper liberalism.”

In his 2006 book, “The Audacity of Hope,” he wrote:

“I was not raised in a religious household...My mother’s own experience...only reinforced this inherited skepticism. Her memories of the Christians who populated her youth were not fond ones...And yet for all her professed secularism, my mother was in many ways the most spiritually awakened person that I’ve ever known. Religion for her was just one of the many ways – and not necessarily the best way – that man attempted to control the unknowable and understand the deeper truths about our lives.”

In one of his many speeches Barry said this:

“The values my mother taught me during my formative years continue to be my touchstone when it comes to how I go about the world of politics.”

The truth about Ann Duham is that she was raised as an Uniterian and became a radical leftist and a cultural Marxist. She had made up her own religion consisting of some things from

the Bible mixed with Hinduism and Taoism. Since Islam is a very oppressive religion for women, she never embraced it, but did have Barry attend an Islamic school.

**Barry is the perfect Manchurian candidate because he has been raised with a number of different religious systems, embracing none of them he is a Muslim to the Muslims, a Christian to the Christians, a Hindu to the Hindus and a Taoist to the Taoists. When the Antichrist comes with the False Prophet, Barry will fit in perfectly since he has no set morals and no set doctrines except when it comes to socialism and Marxism.**

Since Barry’s parents are dead and his grandparents are dead there is no one to ask about where he was born or what kind of religion Barry got from his mother. All we have to go with is the statements of Barry and his sister and whatever existing documentations which have not yet been “sanitized.”

## A STEP CLOSER TO THE WHITE HOUSE

It was time for Barry to move into an elected office to build his credentials on the road to the White House and so he ran for a seat on the Illinois Senate in 1996. With his Jewish backing and as a solid Marxist-Socialist democrat, he had no problems in being elected. Using his skills as a community organizer, he gained bipartisan support for legislation reforming ethics and health care laws. He sponsored a law increasing tax-credits for low-income workers, negotiated welfare reform and promoted increased subsidies for child care. Barry then gave his full support to Republican Governor Ryan’s payday loan regulations and predatory mortgage lending, aimed at averting home foreclosures. Barry raked up a perfect leftist liberal record in the Illinois State Senate and was re-elected in 1998 and in 2002. In an unsuccessful run for a seat at the U.S. House of Representatives in 2000 he was defeated by a margin of two to one.



## GETTING INTO THE BIG LEAGUE

During the spring of 2002, Barry’s handlers decided that it was time to test the waters and see if they could get Barry elected to the U.S. Senate. Polls were taken, a campaign committee was created, funds were being raised and David Axelrod, his mentor of many years took charge of the effort. Barry officially announced his candidacy in January 2003.

Then something strange happened. Incumbent Republican Senator Peter Fitzgerald decided not to run for re-election and the previous Democratic Senator, Carol Moseley Braun decided not to run again either. Some seven democratic candidates for the Senate seat were involved in the primary election but Axelrod’s heavy hand in running Barry’s campaign paid off and Barry won the primary with 53%.

## MORE INTERESTING THINGS

Barry was asked to deliver the keynote address at the Democratic National Convention in the July 2004, and with this exposure his rise to stardom had begun. In the fall election of 2004, the Republican primary winner announced in June that he was withdrawing from the race. The question that immediately comes to mind is who put the pressure on this candidate to quit?

Then something more astonishing happened as the Republican Party in Illinois imported the black American Alan Keyes from Maryland, a Harvard graduate with a Ph.D., and nominated him to run against Barry. Alan quickly moved to Illinois to establish his legal residence. He was pushed in the Christian media as a strong Christian with great values, when in reality he is a strong Roman Catholic and holds a third degree in the Roman Catholic Freemasonry, known as "Knights of Columbus." The race for the Senate seat was rigged and just as phony as the wrestlers in American wrestling, where each wrestler knows in advance who is going to win and who is going to lose. Alan put up a great charade but did it in such a way that he would alienate voters. Barry won with a 70% margin, while Alan got 27%, and the rest was split on independents.



## SENATOR OBAMA

There is not much a first term Senator can do as he waits to build seniority. David Axelrod and the rest of the handlers made sure that Barry would do the right things and avoid making mistakes. Axelrod knew that the war in Iraq would eventually go bad and that the American people would sour on it. After the 9/11 attack in 2001, Barry went on record by speaking out against a resolution authorizing the use of force against Iraq. During his entire time in the Senate, Barry repeatedly spoke out and voted against anything that had to do with the war in Iraq. This was a theme that he hammered on time and time again as he ran against Hillary Clinton because she had joined George Bush and others in voting to go to war with Iraq.

Barry sponsored some legislation but most of the time he would either co-sponsor or just vote for bills other senators had proposed. He was a loyal party member and did not rock the boat. His handlers had made sure that Barry had lived a clean

According to Obama's Kenyan (paternal) grandmother, as well as his half-brother and half-sister, Barack Hussein Obama was born in Kenya, not in Hawaii as the Democratic candidate for president claims. His grandmother bragged that her grandson is about to be President of the United States and is so proud because she was present DURING HIS BIRTH IN KENYA, in the delivery room. This, according to several news sites and Pennsylvania attorney Philip J. Berg who is, surprisingly, a life long democrat himself. Sarah Obama was so excited that she attended the birth of this child and that was going to become the president of the United States. They want the world to know that a “Kenyan boy” has become the president of the United States.

At the time of the election it was hard to determine that there was a split between the Jewish people living in Israel and the American Jewish leadership, which now controls the White House. In the American Jewish magazine “Forward” of July 10, 2009 there was the following headline on the front page:

Supreme Court nominee Sonia Sotomayor is an extreme liberal and will go to any length to protect the abortion (murder) laws, discriminate against white people and use her seat to advance Marxist-Socialism in America.

On January 29, 2009, Barry signed his first bill into law, the Lilly Ledbetter Fair Pay Act of 2009, which eased the requirements for filing employment discrimination lawsuits. On February 3<sup>rd</sup> he signed the Children's Health Insurance Program Reauthorization Act to cover an additional four million children who at that time were not insured.

On February 17, 2009, Barry signed into law the American Recovery and Reinvestment Act of 2009, which was a \$787 billion economic stimulus package. This increased federal spending for healthcare, infrastructure, education, various tax breaks and incentives and direct assistance to individuals. All Americans receiving social security received a stimulus check for \$250 during the month of May, 2009.

Barry's American Jewish friends needed help to get rid of their bad loans from the real estate market, and during the month of March, 2009, Treasury Secretary Timothy Geithner<sup>vii</sup> took great action to manage the financial crisis, including the Public-Private Investment Program, which was authorized to buy up to two trillion dollars in depreciated real estate assets. In clear text, this is what they did: Huge mortgage companies like Countrywide had billions of dollars in bad loans which they had purchased from different mortgage brokers. These bad loans were bought up by the government and the American Jewish investors got their money back while the taxpayers were stuck with rotten loans which will never be paid back.



The financial meltdown in America began many years ago and manifested itself during the last year of the Bush presidency. The people running the Federal Reserve System do not care who is in the White House, every occupant will dance to the tune they are calling.

Between the Bush and Obama administrations, \$11.5 trillion have been authorized of which \$2.7 trillion were spent by the end of June, 2009.

## THE REST OF THE STORY

Countrywide was purchased by Bank of America in July, 2008 and they inherited a large amount of what is called "toxic loans." On September 15, 2008 Bank of America announced its intention to purchase Merrill Lynch & Co, as this brokerage firm was ready to collapse. Kenneth Lewis, Bank of America CEO, testified later before Congress that he had misgivings about the acquisition of Merrill Lynch, but that federal officials pressured him to proceed with the deal or face losing his job and

endanger the bank's relationship with federal regulators. Republican lawmakers in Congress were able to subpoena e-mails backing up this accusation. In one of the e-mails Richmond Federal Reserve Bank president Jeffrey Lacker threatened that if the acquisition did not go through, and later Bank of America was forced to request federal assistance, the management of Bank of America would be gone. Bank of America took over Merrill Lynch on January 1, 2009.

## PAULSON ADMITS PRESSURING BANK OF AMERICA

On July 15, 2009 ABC News reported that former Treasury Secretary Hank Paulson admitted in a congressional hearing to putting pressure on Bank of America's CEO Kenneth Lewis, stating that the Federal Reserve could remove board members, including Lewis, if they backed out on the deal to purchase Merrill Lynch. Lewis and the board of directors of Bank of America in December, 2008, considered backing out of the agreement with Merrill Lynch, when it was discovered that there was a \$12 billion loss which Bank of America would have to absorb.



Prior to this admission by Paulson, he had denied that any pressure had been put on Bank of America or that any of its officers had been threatened. On June 25, 2009, Federal Reserve chairman Ben Bernanke told a house committee that he had never personally threatened to remove Lewis or the bank's board members. It used to be a crime to lie when someone testified before Congress after having taken an oath to tell the truth. But again we can see that it doesn't matter which political party is in the White House, the unseen power brokers do whatever they want to do, and a puppet like Paulson does what he is told to do and is protected by his handlers.

## HOW THE SYSTEM WORKS

Once Bank of America had taken over Merrill Lynch, the U.S. Government gave the bank \$20 billion to take care of the loss, plus a "bonus" of \$8 billion to the bank.

It is chilling to note that on January 15, 2009, US Airways flight 1549 had taken off from New York to Charlotte, North Carolina. Out of the 155 people onboard, 16 of them were Bank of America's top brass returning from a grueling negotiation in New York to their headquarters. According to the official version, the plane struck a flock of birds and both engines died. The pilot managed to glide the plane to a safe landing on the Hudson River in New York. Was this crash planned to take out the top leadership of Bank of America but foiled by the skill of the pilot?

## THE AMERICAN AUTOMOBILE INDUSTRY

Toward the end of 2008, the three American automakers, General Motors (GM), Ford and Chrysler let it be known that they were incurring heavy losses and would go bankrupt if they did not receive help from the government. GM initially received \$19.4 billion in aid and Chrysler received \$1.5 billion which was used to finance car sales at 0% interest for the buyer. During bankruptcy, another \$1.3 billion was given to Chrysler with \$4.7 billion more to continue to prop up the company.

All three CEO's of these corporations were called to come and testify before Congress where they got a bad reception by the political leaders. The leadership of Ford smelled a rat and decided not to take government bailout money but GM and Chrysler bought into the program. Marxist/socialist Barry and his handlers saw the chance to destroy the American auto industry and its suppliers like tire companies, glass companies, radio and other electronic suppliers, etc. In March 2009 the Obama administration intervened and started to put demands on GM and Chrysler. The CEO of GM was forced to resign and the terms for bankruptcy were set. Chrysler was the first to be forced into bankruptcy followed by GM. Since the government had invested money in the companies, it held 60% of the companies and Chrysler was sold off to the Italian carmaker Fiat.



## INSANITY

Before GM and Chrysler were forced into bankruptcy, both companies announced that they were closing many of their dealerships. GM closed 1,100 dealerships at once with more than 900 to follow and Chrysler closed 789 dealerships. This was a move of insanity since each dealership is independent. The buildings and all of the personnel are paid by the owner of the dealership and there is no cost whatsoever to GM or Chrysler. Even if a dealership only sells a few cars, it is still a profit for car manufacturers since the dealers have to pay for the cars when they are delivered. Tens of thousands of Americans lost their jobs, and instead of creating jobs, Barry and his wrecking crew destroyed them. GM was told to sell off several of its assets like the Hummer division, Saturn, SAAB and close the Pontiac division. This threatened the employment of some 100,000 people and caused even more destruction!

There were two kinds of investors in these two companies, bondholders and stockholders. These investments were basically wiped out and tens of thousands of people who invested their savings into these companies will end up losing most of it. People living on these investments after retirement will most



likely be forced to sell their homes and drastically reduce their style of living.

## WHO WON IN THIS OPERATION?

This is the biggest takeover of private industry in the history of the United States and rivals what Hugo Chavez has done in Venezuela when he nationalized most of the private industry. Sixty percent (60%) of GM and Chrysler is now owned by the U.S. Government, another portion is owned by the Canadian Government, a portion is owned by the labor unions and a remaining fraction is owned by former bond and stock holders. Barry and his Marxist/socialist gang have dismantled and taken over the ruins of the once mighty American auto industry with Ford alone left standing.

The only viable manufacturing industry left in the United States is the airplane industry that produces military and civilian aircraft. All other industries have been relocated to Mexico, India, Bangladesh, Vietnam, Thailand, South Korea, Taiwan and China.

## WHO LOST ON THIS OPERATION

All of the suppliers to GM and Chrysler were affected and the money owed to them was wiped out in bankruptcy court. Many of these suppliers, including some manufacturing plants, were forced to go out of business. Millions of Americans have lost jobs which will never come back. All the victims of car crashes in GM and Chrysler vehicles will never be compensated. An order from the bankruptcy court judge on July 5, 2009 stated that GM has the right to free itself of injury and wrongful death claims filed before the bankruptcy proceedings began. The judge in the bankruptcy court for Chrysler has ruled that Chrysler is also absolved from all lawsuits stemming from accidents prior to June, 2009. Are Barry and his gang going to help these people who are sitting in wheelchairs with the cost of their medical treatments and money to live on?

## WHAT IS NEXT?

On the 100<sup>th</sup> day in office, Barry declared that he is “remaking America” not rebuilding it. While honoring himself at a dinner commemorating his 100 days in office, Barry spoke the following:

“...I would like to talk about what my administration plans to achieve in the next 100 days. During the second 100 days, we will design, build and open a library dedicated to my first 100 days. I believe that my next 100 days will be so successful, that I will complete them in 72 days – and on the 73<sup>rd</sup> I will rest...”<sup>10</sup>

Barry is currently pushing for universal health care in the United States. In a typical Marxist-Socialist fashion Barry has a new tax plan. He wants to eliminate taxes for senior citizens with income of less than \$50,000 a year, raise income taxes for people making more than \$250,000 per year, raise capital gains and dividend taxes, close corporate tax loopholes, lift the income cap on Social Security taxes, restrict offshore tax havens, and simplify filing of income tax returns by pre-filing wage and bank information already collected by the IRS.

The opinion piece in *Pravda*, one of the Soviet-era newspapers still published in Russia, carried the headline, ‘**American Capitalism Gone with a Whimper,**’ by Stanislav Mishin.

It must be said, that like the breaking of a great dam, the American descent into Marxism is happening with breath-taking speed, against the back drop of a passive, hopeless sheep, excuse me dear reader, I meant people,” wrote Mishin.

The article claimed that America’s descent took place in three stages:

First, the population was dumbed down through a politicized and substandard education system based on pop culture, rather than the classics. Americans know more about their favorite TV dramas than the drama in D.C. that directly affects their lives.”

Secondly, “their faith in God was destroyed, until their churches, all tens of thousands of different ‘branches and denominations’ were for the most part little more than Sunday circuses and their televangelists and top protestant mega-churches were more than happy to sell out their souls and flocks to

be on the ‘winning’ side of one pseudo-Marxist politician or another.”

It continued, “Their flocks would reject Christ in hopes of earthly power. Even our Holy Orthodox churches are scandalously liberalized in America.” “The final collapse,” said the *Pravda* article, “has come with the election of Barack Obama. His speed in the past three months has been truly impressive. His spending and money printing has been a record setting, not just in America’s short history, but in the world. If this keeps up for more than another year, and there is no sign that it will not, America at best will resemble the Weimar Republic and at worst Zimbabwe.”

Elaborating on the Obama administration’s now-dominant control over General Motors, Mishin mentioned the firing of its CEO by the administration and now its “‘bold’ move of declaring that he and another group of unelected, chosen stooges will now redesign the entire automotive industry and will even be the guarantee of automobile policies.”

Russian “Prime Minister Putin, less than two months ago, warned Obama and UK’s Blair, not to follow the path to Marxism, it only leads to disaster,” the article said.<sup>11</sup>

  - a. Half of all new marriages end in divorce
3. A rise in heterosexual cohabitation
  - a. The number of unmarried couples living together has soared 12-fold since 1960
4. A multiplication of unwed births
  - a. Out-of wedlock births jumped from 5.3 percent to 39.6 percent from 1960-2007

These statistics show the fragile nature of the institution of marriage today. Changing the definition of marriage will have many unintended consequences, which will hurt generations to come. If one redefines marriage, then the family is redefined. If the family is redefined then the nature of parenting must also be redefined.

We are concerned that an attempt to recognize and adjust to one group's sense of alienation may actually confuse future generations of children about their sexuality and blur lines of responsibility in our families. The very definitions of motherhood and fatherhood may be unnecessarily challenged in years to come.

Same-sex marriage is not a civil right. The laws enacted by Congress during a century of struggle for equal rights for African-Americans were intended to eliminate discrimination on the basis of race, not on the basis of an individual's sexual preferences or personal behavior.

Advocates of same-sex marriage want people to think that it can peacefully coexist alongside traditional marriage. But it will create a conflict between people of faith who fervently believe in traditional marriage and the law, which says marriage includes those of the same-sex variety. Those conflicts will always be resolved in favor of same-sex marriage because there can be no 'conscientious objectors' to the law.

Mr. President, you say you desire to unify the nation and to change the politics-as-usual status of Washington. We want to believe this statement. As we have looked at both your policies and recent public affirmations, each of us has asked ourselves

one question, 'Is there room enough for people like us in President Obama's America?'

Many of the people we speak for felt that your disparaging statements during the 40th anniversary of the Stonewall Riot were directed at them. Some of the people with 'worn out arguments and old attitudes' are not bigots or homophobes; they are our cultural elders, who are rightfully saying, 'Don't tear down a fence until you understand why it's there.' Recent studies show that there is a resurgence of hope about marriage among the young people of this generation. Mr. President, let's keep hope alive."<sup>12</sup>

# What Constitutes Racial Profiling?

Harvard Scholar, Henry Louis Gates, was arrested on his front porch on July 16, 2009 by police responding to a call from witnesses reporting a possible break-in at a residence in Cambridge, Massachusetts. It seems Mr. Gates and another man had to use force to gain entry through a jammed door – be it his own.

Apparently, he would not have been arrested and charged with “disorderly conduct” had he simply cooperated with police and shown some identification – something an officer must have upon arrival at a potential crime scene in order to make sure the parties involved are indeed who they claim to be. For an officer to simply assume someone at a potential crime scene is not the perpetrator would be careless, irresponsible and dangerous for everyone involved. Verifiable identities must first be established.

Gates not only refused to cooperate with officers investigating, but also became belligerent in his objections to their request for identification, reportedly getting “loud” and “tumultuous” with police – calling their demands “racial profiling.” Mr. Gates, you see, is an African-American and the arresting officer is not.

The fact that Barack Obama commented on the incident at a Wednesday news conference, saying that police “acted stupidly,” seemed rather odd to me, bringing to mind another controversial identity issue in the news: Obama’s own refusal to provide a copy of his original long-form, hospital-generated, birth certificate to prove his American citizenship – something every candidate for president must do to satisfy the Constitutional requirement of being a “natural born citizen.”

To simply assume that he is, just because he claims to be, would also be careless, irresponsible and dangerous for everyone involved. If it is eventually discovered that he is not a natural born citizen, then everything he has signed into law, every Executive Order he has given and every appointment he made as the President of the United States of America would instantly become invalid and we would have a national crisis on our hands.

You see, Obama’s “Certificate Of Live Birth,” which is posted online, is not the same thing as an original long-form birth certificate – something every American citizen must provide a copy of to get, among other things, a driver’s license, passport or handgun carry permit. Not

only has Obama refused to provide a copy of his original birth certificate, he has also reportedly spent millions of dollars in legal fees trying to prevent its release to the public – that is, assuming he has one.

Legally, it would appear that we don’t really have one until he does – or would that Constitutional requirement also be considered “racial profiling?”

# THE OBAMA HEALTH SPECIAL

Before we had a chance to go to print with our newsletter, some breaking news came out of Washington D.C. telling about the new Obama universal health care plan in the United States. Most Americans are aware that Barry Obama was pushing Congress to the limit to have his health care plan voted on and signed by him before the August, 2009 recess of Congress. However, prayer and millions of e-mails, letters and phone calls to members of Congress made even Democratic Senators and Congressmen take notice and it was agreed that the plan would have to wait until after recess. This is scaring Barry and his handlers since members of congress will get an earful from their constituents once they leave for vacation to their home districts.

I am not going to discuss the financial cost of this plan which will be astronomical but my focus is on the moral and ethical parts of this proposal. In order to save time for myself, I have chosen to include two reports, which will detail some of the issues in the health care bill.

## THE JEWISH TROIKA

When I wrote the article "The Manchurian Candidate," I did not pay attention to the fact that in addition to the American Jews Rahm Emanuel, White House Chief of Staff, and David Axelrod, Senior Advisor to Barack Obama, there was a third man, Dr. Ezekiel J. Emanuel, who is a brother of Rahm. He is deeply involved in writing the health care part of the new bill and setting forth who will be treated, how much treatment they receive and deciding when a person is considered too old and not worth medical attention.



I can see that this diabolic move on behalf of the Obama administration is nothing less than a chapter from the book "1984" by George Orwell (his real name was Eric Blair) in which this British Jew wrote about a coming world system that would be a total dictatorship with no freedom for the individual and where the state had the right to determine how long a person could live by controlling health care. The book was written in 1948 and at that time Eric Blair was a disillusioned Marxist-Socialist who fought in the Spanish Civil War on the Communist side. It is obvious that Blair was breaking with the Jewish leadership and in a subtle way wrote about the future in a novel form but was really telling the agenda of the coming world dictatorship by the Zionist World Federation. He also wrote another book entitled "The Animal Farm," which is a satirical attempt to unmask the corruption in political circles. Even if

Blair was not a Christian and his books are written from a secular viewpoint, each Christian would do well to read them in order to understand the coming Antichrist system.

It is no accident that these three American Jews are now spearheading the destruction of America as we know it. Their goal is not to help the people but to enslave them. Since I have lived 23 years of my life in Marxist-Socialist Sweden, I am well qualified to speak about the new Universal Health Plan that Barry and his handlers are trying to force on the American people. Let me share some of the worst points in the Swedish system of universal health care.

1. People who are deemed healthy enough and in the age bracket 55 years or younger will receive medical attention. But they cannot just go to any hospital; they have to use the one that is assigned as their regional hospital which can be several hundreds of miles away from where a person lives.
  2. If there is an emergency like an accident, heart attack, stroke, etc. the person can receive immediate help. But if it is a chronic problem, they will be given an appointment that might be anywhere from 6 months to a year.
  3. All pregnant mothers are monitored to make sure the baby is healthy. If doctors think that a baby is deformed or will have some kind of birth defect, the mother is told to abort the baby. If a child develops severe physical problems and medical doctors determine that recovery is not possible, the child will be denied further medical treatment and sent to a special care unit where they are deprived of water and dead in less than five days.
  4. The same holds true for adults. If a disease or accident damages a person to the degree which doctors state that recovery is not possible, the patient is sent to the "death unit," where the humane and kind treatment is "no water." In Sweden this is accepted as a dignified way to die without calling it murder.
- It is noteworthy that more and more doctors in the United States are using the "no water treatment" on terminally ill patients. I have witnessed this several times in hospitals and only through persistent and forceful protests did I get this treatment reversed.**
5. Any person over the age of 55 must have an evaluation by medical doctors if they are seeking medical help. Treatment

will be approved if the doctors deem that they might have more years to live and a good chance of recovery. If not, the person is told they are too old and ill to be treated and sent home.

It is even harder to receive decent treatment once a person in Sweden reaches the age of 65. My father was 65 years old and had just retired. He had developed cataracts on both eyes and at the same time was fighting glaucoma. A board of medical doctors ruled that he should not be treated but be sent home to go completely blind. Five years later my brother and I were able to help our parents immigrate to the United States, and as soon as they arrived, we scheduled Dad for surgery. The operation was a total success and a year later he had cataract surgery on the other eye. For the next 15 years our father had great eyesight and was able to enjoy life until he passed away. My father had no health insurance and my brother and I paid for the surgeries because we loved him and were willing to sacrifice to help him out.

## WHAT BARRY IS PREPARING FOR US

There are several versions of a universal health care bill pending in Congress, all of them bad. The one thing they all have in common is less health care for those who are 65 and over, including those who are deemed to be too sick to have a chance to recover.

When I turned 65 some years ago, I didn't necessarily want to enroll in Medicare but I was told I had no choice. Medicare premiums are taken out of my social security check regardless if I like it or not. The Obama administration wants to put all private health insurance companies out of business and force all Americans to be enrolled in a Universal Health Plan and to have the premium deducted like payroll taxes whether they like it or not.

## HISTORY REPEATS ITSELF

In most dictatorships there have been "death programs." The Soviets had them, the German Nazi regime had them, and currently China, North Korea and other Marxist-Socialist states have them. The ruling elite want a life in luxury for themselves and a decent life for the bureaucrats, police and military to give them an incentive to fight for the dictator and his gang while they oppress, exploit, abuse and use the common people excessively. Obama and his handlers are no exception. They are all rich and live well but talk about "helping people." Yes, they are helping people, by "helping themselves" to the money while keeping the people in slavery.

## Dr. Ezekiel Emanuel, Rahm's brother, tapped for White House health care policy advisor spot.

WASHINGTON--While the Obama White House is searching for a replacement for health czar Tom Daschle, policy work on health care reform--a priority for the administration--is ongoing with one key advisor especially well connected.

The brother of White House Chief of Staff Rahm Emanuel, Dr. Ezekiel J. Emanuel, a noted bioethicist, is advising the Obama administration on health care reform.

Dr. Emanuel is the Chair of the Department of Bioethics at The Clinical Center of the National Institutes of Health and a breast oncologist.

Dr. Emanuel is a special advisor to the director of the White House Office of Management and Budget for health policy. He told me he is "working on (the) health care reform effort." He is "detailed" to the OMB spot and is still officially an employee of the NIH.

Until last August, Dr. Emanuel was commuting between his Chicago home in West Rogers Park and Washington. He moved to Washington last August after his youngest daughter graduated from Northside College Prep at Bryn Mawr and Kedzie.

One of three wildly successful Emanuel brothers (Ari is a Hollywood super agent) Dr. Emanuel also advised the Clinton White House on health care issues. He is a graduate of Amherst College, receiving his masters of science from Oxford University in Biochemistry. His M.D. is from Harvard Medical School. He holds a Ph.D. in political philosophy from Harvard University. In addition, in 1987-88, he was a fellow in the Program in Ethics and the Professions at the Kennedy School of Government at Harvard.

According to his NIH bio, Dr. Emanuel is "widely published on the ethics of clinical research, advance care directives, end-of-life issues, euthanasia, the ethics of managed care, and the physician-patient relationship, Dr. Emanuel's articles have appeared in *The New England Journal of Medicine*, *Lancet*, *Journal of American Medical Association*, and many other medical and ethics journals. His book, *The Ends of Human Life*, has been widely praised and received the

Rosenhaupt Memorial Book Award by the Woodrow Wilson Foundation.

“Dr. Emanuel served on the ethics section of former President Clinton’s Health Task Force, the National Bioethics Advisory Commission, and the International Advisory Board on Bioethics of the Pan American Health Organization. He has been a visiting professor at the University of Pittsburgh School of Medicine, UCLA, and Brin Professor at Johns Hopkins Medical School.”

## Ezekiel Emanuel: Deny Coverage to Elderly and Disabled for the Greater Good

Betsy McCaughey brings to our attention the Dr. Ezekiel Emanuel’s views regarding universal health care. Dr. Emanuel is a health policy advisor to President Obama and brother of Obama Chief of Staff Rahm Emanuel, so what he thinks may impact all of us. As Betsy points out, Dr. Emanuel has some very radical views regarding the rationing of health care. Take for example Emanuel’s comments in a 2008 article in which he says cutting costs won’t be easy:

Vague promises of savings from cutting waste, enhancing prevention and wellness, installing electronic medical records and improving quality are merely ‘lipstick’ cost control, more for show and public relations than for true change.

In other words, these procedural changes aren’t really change at all. Instead, he thinks we need change in how we apply health care coverage. As Betsy notes, Dr. Emanuel believes doctors try too hard to apply the Hippocratic Oath to everyone as equally as possible, which is what drives up costs. Instead Emanuel thinks we need to ration basic, guaranteed care to only those who can fully participate in society. Betsy points out a 1996 Hastings Center article in which Emanuel wrote this:

This civic republican or deliberative democratic conception of the good provides both procedural and substantive insights for developing a just allocation of health care resources. Procedurally, it suggests the need for public forums to deliberate about which health services should be considered basic and should be socially guaranteed. Substantively, it suggests services that promote the continuation of the polity—those that ensure healthy future generations, ensure

development of practical reasoning skills, and ensure full and active participation by citizens in public deliberations—are to be socially guaranteed as basic. Conversely, services provided to individuals who are irreversibly prevented from being or becoming participating citizens are not basic and should not be guaranteed. An obvious example is not guaranteeing health services to patients with dementia. A less obvious example is guaranteeing neuropsychological services to ensure children with learning disabilities can read and learn to reason.

So, according to Dr. Ezekiel Emanuel, health care advisor to President Obama, the elderly with dementia and the young who have neurological disorders should be sacrificed for the common good. I can tell you that as a mom to a four year old girl with severe speech apraxia that prevents her from being able to speak intelligibly, this scares the living hell out of me. If you have a child with autism, cerebral palsy, Downs syndrome, or any other neurological disorder or chromosomal defect that prevents him or her from participating in society in the manner Dr. Emanuel or the government thinks they should, that neurological care would not be guaranteed as basic and would, therefore, not be covered in a government takeover of health care.

Making things even worse, private health care companies will be driven out of business, so that won’t be an option for parents with disabled children, either, leaving them with no coverage whatsoever. This kind of policy would drive up the abortion rate, which Obama and other liberals want covered as a basic care, as doctors urge parents go out of their way to screen their unborn babies for any and all disorders and defects that would not be covered under basic care. If a child’s disorder is undetected by prenatal testing, what happens when the disorder becomes obvious after birth? I shudder to think what the government would come up with then.

Emanuel’s policies would lead to a further deterioration of our nation’s culture as people begin to look at those with disabilities as objects that drive up collective health care costs instead of as individual human beings who have intrinsic value and rights endowed to them by God.

# George Tiller the Baby Killer

George Tiller - the infamous late-term abortionist and medical director of Women's Health Care Services in Wichita, Kansas - was killed on May 31, 2009.

Tiller was one of only three nationwide abortionists that make a living injecting digoxin into the beating hearts of small infants from the 21st week of pregnancy to birth. This man put Kansas on the map as the "abortion state" with his entrepreneurial spirit in capitalizing on abortion services.

In addition to being a hit man for hire, Tiller also offered funerary services to mothers that paid him to off their kids. While most clinics in the nation are content to just rape and scrape, Tiller took his practice leaps and bounds beyond the norm and peddled abortion packages that included photographing, footprinting, handprinting, baptism, cremation, and arrangement for autopsy.

George Tiller personally killed more babies than America lost soldiers in Vietnam. Although he specialized in killing handicapped children, most of his tiny victims were late term, fully-formed, healthy, and viable outside the womb. He performed an average of roughly seven post-viable abortions per week and has admitted on tape to aborting babies a day before the mother's due date.

Despite his radical dealings in abortion extremism for over 35 years, Tiller has been met with physical violence only three times in his career of mass baby slaughter. His clinic was bombed in 1985. On August 19, 1993 he was shot in both arms outside of his Wichita clinic. And on May 31, 2009 Tiller was shot to death as he served as an usher during church services.

Murder is murder, and it is something that we pro-lifers inherently deplore. But I can't help but note - and my history is rusty so pardon me here - I'm trying to remember, did anyone mourn Lee Harvey Oswald when Jack Ruby gunned him down? Or better yet, did anyone mourn the deaths of Ted Bundy or Jeffrey Dahmer, or any other mass murderer for that matter? Even according to the harebrained pro-choice life-at-viability reckoning, Tiller was indisputably a

mass murderer who was executed in a fashion far more humane than the tens of thousands of children that he mutilated and left to die in cuddle session bassinets.

I mean, think about it. Someone just shot a Nazi guard manning the gas chamber at Aushwitz. I should feel bad about this? George Tiller the Baby Killer's acts are every bit as vile as the Nazi war criminals who were hunted down, tried, and sentenced after they participated in the "legal" murder of the Jews that fell into their hands.

The lone wacko who gunned Tiller down was not associated with any single pro-life organization or group. He was working solo and his acts rest on his head alone. So why, exactly, are pro-lifers doing back flips to appease the abortion mongering moonbats that seek to elevate Tiller to martyrdom and sainthood?

Instead of scrambling to feverishly denounce the pro-life community ("Anyone who thinks Tiller's death is in any way a positive thing is not a true pro-lifer"... huh?) we should be looking at a very serious fact: If every single pro-lifer who is currently falling all over themselves to publicly mourn the "loss" of this abortionist displayed just a fraction of that outrage over just ONE of the children Tiller murdered on a regular nine to five, Baby Killer Tiller would have been put out of business long ago and he would not be dead today.

Over the years there have been multiple opportunities to peacefully and legally hold George Tiller accountable to his actions, thus shielding him from acts of extremism. An example would be his trial that took place in March of 2009. Being charged with 19 misdemeanors he got off scott-free through corrupt political ties and professional dishonesty. Again, had justice been served in that courtroom, Tiller would be alive today and serving a sentence behind bars.

Is the pro-life position one of violence? Of course not. It is because we are so peaceful that lone acts of extremism immediately garner national attention. In the course of a 36 year genocide, only five abortionists have been killed.

According to government statistics from the National Institute for Occupational Safety and Health, for every abortionists killed, over thirty clergy members have been murdered. Where are the candlelight vigils and 24/7 news coverage for these victims of political violence?

According to the Coalition to Stop Gun Violence, every day more than 80 Americans die from gun violence - many of these being senseless death with the victims innocent of any wrong-doing. And here we have a man who made a living peddling death, who reaped what he had been sowing for over 36 years at \$5,000+ a pop. Does this honestly surprise anyone?

Pro-lifers need to stop hyperventilating over the pro-aborts who are having aneurisms synthesizing mock outrage at Tiller's demise. We need, now more than ever, to keep things in proper perspective.

I know this is a huge loss for Tiller's family and they need our prayer and support. I'm sure they are grieving bitterly, and it is heartbreaking to think of the pain that they must be feeling. It is ultimately tragic that Tiller did not have an opportunity to properly prepare his soul to face his Maker. Unless some miracle happened, he left this life with his hands drenched with innocent blood.

While it is imperative that we extend love and grace to the family of Tiller, we still cannot afford to lose sight of the fact that George Tiller was a mass murderer of the worst kind who made a living off of killing babies and harming women. Unless you are radically against capital punishment, those who view abortion as murder agree that the penalty for the crime of mass child slaughter is death. And although the method and means of his execution is deplorable, the ultimate outcome is not.

The man chose his fate the moment he dismembered his first infant. I'm not embarrassed to say what the punishment for the crime is anymore than I'm embarrassed to admit that child killing is a crime.

Did I want him to be gunned down in church - even a hypocritical, Molech-worshiping fraud of a church like the one he was attending while shot? No. I would have much preferred him being tried and convicted in a court of law that is consistent with medical science and personhood as defined in our Constitution. We can prevent the atrocious

acts of violence against abortionists by holding them accountable to their actions.

There is no doubt that Tiller deserved to be executed for his crimes. I just would have preferred a state sanctioned lethal injection, hanging, firing squad, electric chair, good old fashioned stoning, what have you.

The sooner pro-lifers stop giving pro-aborts wiggle room in their perpetual playing of the victim card, the better. We need to reveal to the nation what this man did for a living and shed even more light on the grisly details of abortion. Our pointless pacifism and back-peddling in the face of this tragedy is helping turn George Tiller into a hero for the pro-abort crowd.

Already, the pro-deathers are making absurd comments such as, "Tiller was truly pro-life, he helped women and was willing to sacrifice his own life for them!" Well, if pro-aborts can dub Tiller "truly pro-life", then in all fairness I guess it's safe to say that his killer was truly "pro-choice". He believed in the idea that if a person's existence troubles you, you have the right to kill them. He also obviously strongly felt that every abortionist should be a wanted abortionist. Is it not a personal decision? His ammunition, his choice? Everybody has an opinion... can't we all just get along? Find common ground, like Obama asked us to?

I mean, I personally would not shoot an abortionist, but who am I to impose my morality on someone else? If you are against shooting abortionists, then don't shoot one, right? Hmm, suddenly pro-choice rhetoric doesn't sound so warm and fuzzy and virtuous, does it?

# America's Public School System: Brutal and Spartan

The public school system in America has become a dismal failure. But education in many other times and cultures has been quite successful. The ancient Greeks, whose civilization was at its height around 550 B.C., founded Western civilization as we know it. The Athenian Greeks invented or perfected logic, drama, science, philosophy, astronomy, mathematics, literature, and much more. Yet ancient Greece had no compulsory schools.

Other than requiring two years of military training for young men that began at age eighteen, Athens let parents educate their children as they saw fit. Parents either taught their children at home or sent them to voluntary schools where teachers and philosophers like Socrates, Plato, and Aristotle gave lectures to all who wanted to learn. These great teacher-philosophers did not need a license to teach, nor did they have tenure. The ancient Athenians had a free-market education system. The thought of compulsory, state-run schools and compulsory teacher licensing would have been repulsive to them. The Athenians respected a parent's natural right to direct the education of their children.

In contrast, Sparta, Athens's mortal enemy, created the first truly state-run, compulsory education system on record. Individual Spartans lived and died for the State, and had to serve the State from birth until sixty years of age. Their society was a brutal military dictatorship in which male children literally belonged to the city rulers, not to their parents.

The Spartan military government took boys from their homes and parents at the age of seven and forced them to live in military-style barracks for the rest of their lives. Spartan men were life-long soldiers whose highest duty was to obey the commands of their leaders. It is no coincidence that Sparta had compulsory, state-run education. If a society believes that children belong not to

parents, but to the State, then the State must control children's education by compulsion.

Are our public schools any different than the brutal Spartan society in the way they treat parents and children? Today, school compulsory-attendance laws force parents to hand over their children to government employees called teachers for eight to twelve years. In effect, our local and state governments claim that they, like the Spartans, own our children's minds and bodies for twelve years. Parents who refuse to hand over their children to the public schools can be, and have been, locked in jail for disobeying the compulsory-attendance laws.

In this respect, our public schools today are just as brutal as the Spartans. The difference is only in degree. Where the Spartans stole children from their parents to serve a lifetime in their military, our local governments create laws that let them, in effect, legally kidnap our children to serve twelve years in their education boot camps called public schools. The brutality of the principal is the same.

Both the Spartans and our public-school officials think they own our children, and have utter contempt for parents' rights.

# PEARL HARBOR for THE CHURCH - A Vision

In December of 1984, about a week after I purchased an old 1940 Cadillac sedan, I was driving around thinking about times gone by, particularly the time before and during World War II. Suddenly I heard the Lord say to me, very softly, "It's 1940 and Pearl Harbor is coming up for the Church." I thought about betrayal, warfare, death and awakening! I prayed to the Lord about it and He began to reveal to me more about Pearl Harbor. He reminded me of a scene from the film, "Tora Tora Tora," in which one of the Japanese military leaders remarked, after their attack on Pearl Harbor, "I fear all we have done is to awaken a sleeping giant and fill him with a terrible resolve." I thought about the Church finally waking up to her true condition. I thought about the terrible price our country paid in the 1940's to wake up to the realities of the world political situation. The price was human life, suffering, and destruction. But we did wake up. I thought about December 8, 1941, when we declared war against the Axis powers. Before that time we were sending arms, supplies and money to our allies, but we were not sending men to help fight. We watched China, the Pacific Islands, France and much of Europe fall to Germany, Italy, and Japan, but we were not personally affected so we did not enter the warfare. It took a catastrophic event to wake us up.

I prayed about and meditated on what I had heard until May of 1985, when I again heard from God during a baptismal service in our Church. The person to be baptized was an older lady who was quite concerned, even a little frightened, about being fully immersed.

But she, after fifty years of disobedience and rebellion against God, desired to be baptized for the first time. Right before I was going to enter the water with her, a message in tongues came forth from my wife. The Lord gave me the interpretation by means of the following vision. This vision describes a future time of great hardship and great blessing for the Body of Christ.

He showed me a deep harbor with blue-green water that was clear and calm. There was a Person in the water. This Person was not swimming or standing, but just floating in an upright position. He was motionless, like a sailing ship listing in a windless sea. Many Japanese Zero aircraft came in from the east and proceeded to dive-bomb and strafe the body in the water and the body began to slowly sink. Eventually the body was entirely under the

water. As he went down, I could see that there were many little people on this Body. As this Body sank deeper into the water, many of these small people jumped off just before they were about to enter the water. There were thousands of people jumping off and swimming away from this slow but steadily sinking Body. Some of these people jumped onto beds, which the Lord made clear to me were beds of adultery, and floated away off to the left. Others jumped onto whiskey bottles and paddled away; still others jumped on books, while others swam off on their own strength. All of the people were floating, swimming or paddling in the same direction.

I looked over in that direction, which was to my left, and I saw an extremely beautiful, gigantic woman, with skin and clothing of a deep reddish purple hue standing solidly on the harbor floor. She stretched out her arms toward the sinking Body and got the attention of many as she very sweetly, seductively, and sincerely called out, "Come unto me all ye that are weary and heavy laden, and I will give you WHAT YOU WANT!"

The people who were jumping off were in a panic, like rats leaving a sinking ship. Some scurried to higher ground on the Body, going from the shoulders to the ears and finally jumping off the top of the head right before it went under. It was clear that THEY DID NOT WANT TO LEAVE THIS BODY, but it was equally clear that they were not going down under the water with it either. The Body now was completely under the water, sinking steadily toward the bottom. Some of the little people hung on as it sank, but after a few seconds of holding their breath, they gave up, swam for the top, gulped a mouth full of air, and swam off toward the woman.

The apparently lifeless Body sank deeper and deeper into the clear blue-green water. As it sank I could see at the bottom of the harbor a beautiful, large, perfect pearl - obviously of great value. It was supernaturally large and beautiful, lustrous, pure and round. As I watched, I could see the Body change shape from that of a single being, with little people desperately hanging on it, to many little individual people swimming deep enough to get to this beautiful Pearl. As they went deeper, many chose to quit and swim to the surface for air and life and then go over to the beautiful woman. All who quit diving eventually swam over to the beautiful woman.

Finally, I saw a number of these small people swim to the Pearl and touch it, and embrace it. But to do this, everyone who dove down reached a point when they realized that their own natural ability to hold their breath and dive deeper would not be enough.

Those who dove down and touched this Pearl all came to understand that they would have to expend all of their natural strength before they touched and embraced the Pearl of Great Price. This did not keep them from diving down though, because the closer they got to the Pearl, the more of His beauty they saw.

I saw many touch and embrace the Pearl and then immediately shoot straight up. As each of these little people shot up from the floor of the Harbor, each had the Pearl. As this group of individuals rose higher and higher, they all became one Body again. By the time these Pearl-laden people reached the surface they burst forth from the waters as one Body, the Body of Christ. These people were manifestly His own possession and they in turn possessed the Pearl of Great Price, Jesus Christ Himself.

As the Lord was showing me this beautiful picture, He spoke to me and said, "Even as Jesus came out of the waters of baptism, so My Body will come out of Pearl Harbor with a new and powerful anointing of My Holy Spirit, and a new and deadly power to fight the enemy." He said that there indeed would come upon the Church of Jesus Christ a Pearl Harbor experience like the United States experienced on December 7, 1941. He said that when the Body of Christ begins to sink under the water, because of a soon-coming, devastating attack of the enemy, MANY will choose to desert our Lord Jesus Christ because they do not esteem the Pearl of Great Price (Jesus Himself) worth the price - death to their own selfish desires. They will not make the selfless effort of love to dive deeply enough to embrace Him because they do not love Him more than their own lives. Many will choose not to identify with what they assume is a defeated individual or group. They look upon themselves as winners and will not identify with a Jesus that is apparently being defeated. They will choose to identify with the beautiful woman of the harbor who gives them what they want. As the vision revealed, many who leapt off the sinking Body because the woman of the harbor promised them success. Because of this they went to her. Many others did not feel that it was necessary to pay such a high price to apprehend Jesus, and they felt that the beautiful woman would give them Jesus on their own terms.

As the Body of Christ came out of the waters of death, the Lord said that His Body was now fully alive

and would now fight the enemy with purpose and real anointing. Also His Body would now use only supernatural weaponry. He spoke so clearly to me about the weapons. He said, "Even as the United States entered the Second World War using conventional weapons to fight the enemy, and ended the war with the atomic bomb, a weapon beyond their comprehension; so My people will begin this spiritual war with conventional weapons in the Spirit, but by the end of this war to end all wars, they will be using atomic bombs of the Spirit." The Lord made it clear that we will come out of the water equipped with God-given anointing to REALLY heal the sick, work miracles, and deliver those in demonic bondage. He also made it clear that before the warfare ends, we will be moving in a dimension of spiritual warfare that is unimaginable to us now. We will do greater works than Jesus did and we will see the demon hordes routed like never before.

After this message in tongues and interpretation was given, my attention turned back to the woman who was to be baptized. Then the Lord said that the Pearl Harbor experience for His Church would be similar to this woman's baptism. I closely watched this baptism to see what the Lord meant. The woman was very nervous and quite afraid of going under the water. I assured her that she would be all right. After several moments of prayer and a short teaching on what baptism represented, she was plunged underneath the water. She came out of the water with her hands lifted up, praising God. I had not told anyone what the Lord told me about this woman's baptism, because I did not know exactly what was going to happen. When she recovered her composure, she began to testify about what had just happened to her. She said that she was extremely fearful at first, but that when she got under the water a Beautiful Peace swept through her, and all her fear was gone. This beautiful peace became joy as she came out of the water and she praised God for His great comfort, love and mercy.

I believe that God was showing us that we need not fear what He will put us through. His purpose is to bring us peace, joy, cleansing and power. He was also showing us that His Church will go through a baptism. It is a baptism of the Body of Christ.

It is a death and a resurrection. We must trust Him to bring us out of this watery tomb of death and into the glorious resurrection power of His Son. We must understand that a harbor is a place of SAFETY and REFUGE. God's people who are involved in these events will need to be safe and protected. The Harbor of the Pearl of Great Price is the only harbor that will provide

refuge and safety, and ALL who believe will be more than willing to pay the price of dying to their own desires.

Pearl Harbor is the death and resurrection of the Body of Christ, being prepared to do His work in His way, with His heart. It is the final separation of David from Saul - the David Church being purified and separated from the Saul Church.

It is the final AWAKENING blast of the trumpet of God to rouse His people for battle. It is the judgment that begins with the house of the Lord. It is the refining fire that separates the gold from the dross. It will be preceded by the Lord dealing with His true people to both survive and desire this final preparation for battle. It is the promise of unmatched power and purity: power over sin, power over the enemy, power to live a much more virtuous life, and power to glorify our Heavenly Father through Jesus Christ by the power of the Holy Spirit. Even now, God is dealing with those in the David Church even as God dealt with David. Whenever David would start to fall asleep to God's purity and purpose, the Lord would abruptly DEAL with David to AWAKEN him. God did not waste this kind of effort on Saul because Saul CHOSE to be asleep to God and His desires.

Pearl Harbor is a warning of betrayal and disaster. The Church in the past has gone through many Pearl Harbors of betrayal and disaster. Jesus was betrayed and killed and rose again. English Puritans experienced Pearl Harbor in the early 17th century and survived because they could not obey the law that the Church of England tried to force them to obey. They fled England and eventually sailed to the New World, where they laid the spiritual foundation for what eventually became one of the greatest revivals in the history of the world. John Bunyan wrote "Pilgrim's Progress" at the bottom of the harbor as he was betrayed by his own country and thrown in jail for not attending the services of the Church of England and for preaching in a way that did not conform to this church's liturgy. Had he given in and done that which they asked he could have been a free man. But for conscience' sake he chose not to do so. Because of this uncompromising obedience to the Scriptures and to God Himself, he was able to rise to the highest place in the history of Christian literature. Today he still blesses us with the fruit of that resurrection power.

To those who are not awake and prepared, Pearl Harbor will come suddenly and tragically, as a thief in the night, and they will be swept away to Great Deception. To those who are more open to the will of God than they are to pleasing religious men, it will be an expected ordeal, a call to arms, and a prelude to great victory. The initial

stages will be the harbinger of the greatest move of God in history, the greatest Revival and the greatest manifestation of Christian Unity that the world has ever known.

# Is Ted Pike Anti-Semitic?

It was with great sadness that I read a letter from Ted Pike which I am including below in which he tells about a boycott he is receiving from the mainstream Christian leadership. I have never met Ted in person but we became good friends back in the mid 1980's and we have exchanged material we each produced. He has received *The Dove* magazine and *The Flaming Sword* newsletter from me and we received his newsletters. We carry his book, *Israel: Our Duty – Our Dilemma*, which was a bold move on his part to let Christians know the truth about our relationship with the political State of Israel.



Most mainstream Christians are indoctrinated as Christian Zionists, whereby they believe that if a Christian does not bless the political state of Israel, then God will curse them. If you ask a Christian where this is found in the Bible they will turn and refer to the blessing of Abraham (Genesis 12:1-3; 22:16-18), but if the text is carefully read, it never states anything about the State of Israel, and in the New Testament, Paul states that the seed of Abraham are the born again believers in Christ (Romans 4:11-16; 9:1-8). Paul makes it very clear in that Jews and Gentiles alike must come through Christ in order to be counted as heirs of Abraham (Galatians 3:16-29).

According to the American Jewish leadership, Ted Pike is anti-Semitic but let's be fair and define exactly what anti-Semitism is and is not. **According to the World Zionist Federation, the ADL and all other Jewish organizations, an anti-Semite is any person who does not support the political state of Israel, is critical of Jewish policies or exposes historical facts which are not kind to Jewish people.**

It is interesting to note that the mainstream Christian leadership in the United States doesn't care if Christian researchers examine different religions like Islam, Hinduism and Buddhism. Books on these subjects are readily available in Christian bookstores and many of these stores are owned and operated by American Jews. So it doesn't produce any problems if books are very critical of different religions. Christian researchers examining and writing critical books and articles about the Mormons, Jehovah's Witnesses and other sects that have deviated from Christianity do not raise any concern because the Christian bookstores make hefty profits on these sales.

But if a Christian researcher decides to investigate Judaism, where it came from, what they have been doing in

the past and what they are doing now, this is unacceptable to the American Jewish leadership and they have instilled a great fear into all mainstream Christian leaders about the threat of being labeled as anti-Semitic. They know that if they are labeled as such, their finances will dry up and they will be boycotted and driven into isolation. If a minister is on the radio and television, it will not take long before he is forced off the air. No publishing houses will print his books and the media will never mention his name. As far as the world knows, the person will no longer exist.

Ordinary Christians are clueless about all this. If you're reading this and this is new to you, I know you find this hard to believe but I challenge you to contact Christian ministries and ask them why they are not talking about Ted Pike and giving him credit for what he has done. Ask them what Ted has done that is so horrible to warrant being labeled an anti-Semite? I don't believe that any ministry will dare to respond to your questions because they have no answers and are operating out of fear of American Jewish power.

Please read Ted's letter below and then start checking things out. I have written a series of articles called, *Dancing Around the Golden Calf*.<sup>1</sup> Please read them and start to think, pray and do your own research, and you will come to the same conclusion that Judaism is the cradle for the coming Anti-Christ. Send links to all your friends and let's break the monopoly of power of the Jewish leadership and expose them.

I don't hate the Jewish people nor does Ted Pike. Neither one of us hates the Muslim's, Hindu's and Buddhist's. On the contrary, we love all people and our aim is to present Jesus Christ and see them born again. ## UNITE AGAINST HATE LAW TYRANNY!

When Hitler and Mussolini came to power, parliamentary governments had been in place in Germany and Italy for at least a half a century. These dictators established political power outside legislative due process, under the guise of national emergency. They ruled by fiat - claiming such was the only efficient way to regain national power and honor. In just this way, Democrats betrayed justice in the Senate this past week.

On Thursday, with audacity Sen. John McCain said is "breaking new ground," Democrats approved their hate bill in disregard of literally *every* constitutional restraint on tyranny. They defied adequate and fair Judiciary hearings, Mark-up session, Rules session and allowance of open debate before a quorum on the Senate floor. This is not the American way. It is government and law by legislative fiat, the way of Napoleon, Hitler, Mussolini, and Stalin.

It is tyranny.

How should lovers of freedom respond to this and other coming assaults on liberty? The hate bill victory is a green light for ADL-inspired hate laws such as ENDA and cyber-bullying bill, HR 1966. Having passed the landmark hate crimes bill via totalitarian means, Congressional Democrats will continue their strategy with even greater boldness.

Patriots of *all* religious and political persuasions must unite with a shout of protest against further shattering of freedom.

### Disunity Plagued Hate Bill Opposition

Liberal activist groups welcome any faction, no matter how depraved. Such cooperation has not existed among conservatives in opposition to the hate bill this winter and spring.

As early as late December, I began to broadcast and write against the hate bill. I phoned new right leadership groups, encouraging them to jumpstart education and offensive

action. Over the past seven months, I have given 196 radio interviews, posted 72 articles and created 5 short documentary videos against the federal hate crimes bill. I provided the calls to action that slowed what might have been extremely rapid passage of the hate bill. (Action, Not Just Prayer, Can Kill Hate Bill)<sup>2</sup>

Yet for the first nearly four months of the hate bill's progress, except for WorldNet Daily, the evangelical right responded with silence and inaction. The religious right only finally came alive after I dramatized the House Judiciary's rejection of Rep. Steve King's demand for a pedophile-excluding statement on the hate bill, as well as Rep. Alcee Hasting's enthusiastic support of the hate bill's protection of pedophiles. The most striking form of protest that finally emerged was WorldNetDaily's campaign (initiated by Janet Porter) to FedEx hundreds of thousands of form letters to the Senate. This was fueled by a continuous stream of WND articles opposing the hate bill. With the notable exceptions of Focus on the Family and Family Research Council, a number of evangelical watchdog groups, particularly Traditional Values Coalition and Faith2Action, began to loudly militate against the hate bill.

Yet if you read their articles or listen to their broadcasts, you will notice that to this moment, there is no mention of the in-depth educational ministry of the National Prayer Network and its website, [www.truthtellers.org](http://www.truthtellers.org). Our website, if visited by countless Christians/conservatives, could exponentially energize hate law opposition.

### Boycotting Ted Pike

Early this winter an evangelical leadership source told me that he listened to a telephone conference between top evangelical leaders concerned about how to stop the hate bill. He said that all major watchdog groups agreed nothing should be said or done to indicate any association with "anti-Semitic" Rev. Ted Pike. Another leadership authority told me WND's Joseph Farah was particularly determined his online newspaper generally say nothing that might suggest influence from me.

Does this help explain the initial nearly four-month silence of most of the religious right toward any recognition of the hate bill threat? Were they afraid that, if they popularized the issue, people would flock to the world's preeminent website in opposition to hate laws? Would people discover the ADL (Jewish supremacist) origin of hate laws, undermining evangelicals' claim that hate laws originate with liberals and homosexuals? It is likely.

For the past seven months, I have repeatedly seen the religious right ignore vital information about the hate bill threat and opportunities to defeat it for only one possible reason: they didn't want to be seen as influenced by me.

After Janet Porter, head of Faith2Action, informed me that conservative witnesses were being turned away by Sen. Leahy's Senate Judiciary Committee, I immediately quoted her, mounting a national campaign of protest. She called back to tell me that Andrea Lafferty of Traditional Values Coalition and some of her radio listeners had "reamed her out" for even talking to me! She warned me that if ever again I mentioned publicly that I had talked to her, she would never answer any call from me ~ even concerning an imminent hate bill threat!

On July 10 and again on July 12, I emailed WND's Bob Unruh and Joseph Farah that the hate bill would be coming to a vote very quickly and they must rally immediate protest. WND responded by posting articles on such topics as Obama's dubious citizenship all week until 11:35 p.m. Wednesday, July 15.

The hate bill passed on Thursday.

### **The "Threat" of Ted Pike**

St. Paul asked, "Have I therefore become your enemy by telling you the truth?" (Gal. 4:16) I am only a "threat" to deep, habitual error that leads evangelical leaders and their followers into unholy alliance with spiritual and political wickedness. I testify that they and their fathers are guilty of holding to an unbiblical policy of unconditional support of Israel. This has led to carte blanche approval of more than 60 years of the most horrendous human rights abuses against the Palestinians. Their inflexible policy of non-criticism of Jewish supremacy, including its ascendant control of media, government, finance, education, etc., as well as hate crimes laws, has effectively built the walls of the coming Judaic New World order, "Babylon the Great." (Jews Confirm Big Media Is Jewish)<sup>3</sup> Their refusal to criticize matters Jewish is responsible for allowing ADL to attain legislative dominion over Congress.

I bring the accusation that they have not guided and guarded their Christian flock as true and faithful shepherds. They have feared Jewish supremacist wolves more than they love their lambs. They flee for fear of the Jews rather than lay down their lives (and reputations) to protect the flock God has entrusted to them.

It's debatable who fears me most: evangelical leaders or ADL! But, as we saw through my initiation of massive protest last week (leading directly to acceptance of the Brownback

amendment), all I have done has borne good fruit - not evil. The Brownback amendment will help protect free speech in the most vicious, freedom-destroying legislation ever passed by Congress.

### **Is Ted Pike Anti-Semitic?**

I have never uttered an anti-Semitic statement ~ because I am not anti-Semitic. Anti-Semitism is the racist belief that all Jews are genetically conspiratorial, degenerate, or corruptive. Hitler believed that. He thought the world would be a much better place without their existence and took steps to actually bring it about.

I believe the problem with Jewish supremacists in media, government, finance and Israel is that they, like their literal or spiritual forefathers the Pharisees, have made many, many bad moral decisions.

As a result, I, like the Hebrew prophets, must rebuke them (or any sinner) as the Lord leads. I do this in hope they will repent, as did St. Paul, who said, "My heart's desire and prayer is that Israel be saved." (Rom. 10:1) If I fail to reprove or warn, or if I do not speak the whole, undiminished truth as God directs, I jeopardize my eternal soul. (Ez. 33, Jer. 26:22)

If I am anti-Semitic, then Jesus, John the Baptist, and *all* the prophets were raving anti-Semites! They scathingly reprovved all Jewish sinners, especially those abusing high authority. Thus far, God has not led me to criticize evil Jewish leaders in language as searing and condemnatory as Jesus used in His incendiary attacks on the Pharisees!

### **We Can Trust the Truth**

A central problem with Israel-first leadership and laity is that they fear the consequences of telling the whole truth about ADL authorship of hate laws, Jewish control of the media, Jewish origins of Communism, etc. (Jewish Activists Created Communism)<sup>4</sup> They fear the whole truth will bear evil fruits - an outbreak of rampant anti-Semitism, persecuting God's chosen people and frustrating His desire to preserve and redeem a remnant of them at His second coming. Actually, evangelical leaders are in much greater danger of provoking anti-Semitism by quenching the truth. By exempting the vilest Jews from criticism and letting ADL establish oppressive hate laws worldwide and legislative control of Congress, they empower ADL to arouse the bitterest resentment of those they would enslave. ADL, not Ted Pike, is much more likely to provoke worldwide anger and even virulent, vulgar anti-Semitism.

The whole truth is a fresh, cleansing wind that redeems society. Jesus said, "You shall know the truth, and the truth shall set you free." (John 8:32) Truth-telling is the affirmation of reality. Until we embrace and serve truth completely, we will forever parse and manipulate reality in a vain, self-defeating attempt to be safe and respectable.

As we have seen over the past several weeks, the evangelical right, knowing full well the imminent danger of hate bill passage, yet deciding to ignore my calls for action, only made themselves foolish. The depths of such foolishness were plumbed the previous week by the recommendation of Dr. James Dobson and FRC's Tony Perkins that everyone should end all attempts to defeat the hate bill and just pray.

Eventually, after I alerted them that homosexual calls in favor of the hate bill exceeded those of Christians against it, evangelical leadership groups finally did what was right. They worked with God and with me to create a massive three-day hate bill protest that continued just as strongly on Friday, the day after hate bill passage! When they did what was right, instead of being narrowly protectionistic and reactionary, God blessed us with adoption of the Brownback amendment.

But the question remains: If Christian/conservative leadership groups had been as proactive and vigilant as the National Prayer Network, might the hate bill have been defeated?

One thing is sure. Considering the darkness that looms before us, we dare not repeat our mistakes.

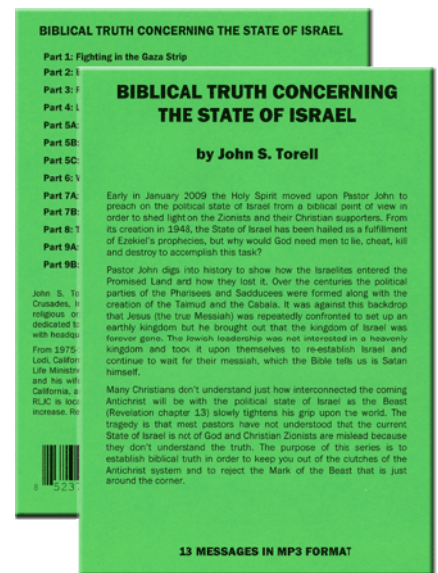
