LONG TERM PLANNING AND DEVELOPMENT

In the previous message we established the theology of the Antichrist system and in this message we are going to look at the people who are used by Satan to run his Antichrist system.

The people in charge of this system are Jewish but not all Jews are part of this system. I believe the vast majority of Jewish people down through the centuries were not part of the Antichrist system and did not have knowledge what was going on with the Cabalistic Jews.

The Jewish rabbinical system was taken over by Cabalistic Jews as early as 700 years before Christ and their damnable teaching destroyed the moral fiber of the people and led them into idol worship. Evidence of this can be found in the prophet Isaiah's description of that time. **Isaiah 59:1-16**

A NEW JEWISH MESSIAH

Simon Bar Kochba (son of the star) started the war against Rome in 132 A.D.; he retook Jerusalem and erected an altar on the old Temple ground.

In 135 A.D., Simon and his remaining forces fled to the small town of Bettar southwest of Jerusalem. The Jews were able to hold the city for several weeks but Roman spies found a secret way into the city, and once inside, the Roman soldiers raging hatred for the Jews was evident because Simon bar Kochba and his soldiers all were killed. According to Solomon Grayzel, 580,000 Jewish soldiers were killed, tens of thousands of civilians were slaughtered by the Romans, and large numbers of Jews were gathered up and shipped to the slave markets in Rome and other cities.⁴

A POLICY SHIFT

Satan had deceived the Jewish leadership into trying five times to establish a Jewish political state where their messiah could rule. Satan shifted strategy as he realized he could not establish world control by Jewish military power alone. It had to be done in a different way, and a different preparation was done for the next 1,600 years.

Trade and banking would be the road to world control since Jewish people were spread out all over the Middle East and into the Roman Empire. If Satan could move the Jewish leadership to take control of trade and banking, they could in turn control the politics of the nations.

Several classes were developed among the Jewish people after the last disastrous uprising in 135 A.D. Merchants and private bankers existed at the time of Jesus and thousands of them returned to Jerusalem every year to take part in temple ceremonies. **Acts 2:5-11**

Cabalistic rabbis were fighting orthodox rabbis and the Jewish people ended up in different “religious” groups. The merchants and bankers gravitated toward the Cabalistic leadership while the poor and uneducated Jews stayed with the orthodox teaching. Many Jews in different places of the world would declare themselves to be the “messiah” for the next 1,900 years and would gather Jewish people who believed them.

In 325 A.D. when Christianity had become a state religion in the Roman Empire, the new rulers needed the skill of the Jews, who had by this time had become established money-lenders and bankers. The Roman Catholic Church forbade “Christians” to work in this area. Jewish merchants and traders rose to the top for several reasons:

1. Their language of Hebrew and an early form of Yiddish became a private global language and gave them the advantage of being able to communicate with other Jewish traders and bankers regardless of the nation where they lived.

2. The Cabala and the Talmud gave them a common religion which had its own codes of conduct. As a result, they had a global religious and law system which gave them a court system in which they could settle legal matters between themselves.
3. They were able to retain their unique nationality because they refused to assimilate into the different nations and created a strong feeling of Jewish versus Gentile.

During the reign of the Frankish kings, goods were moved between the European “Christian” nations and Naples and Palermo, which at the time were under Islamic rule. Jewish traders had their own ships and plied the Mediterranean Sea.

Jewish merchants known as “Radhanites” traveled through Europe, the Middle East and the Far East all the way to China between the sixth and tenth centuries trading in spices, silks, coins and Jewels.⁵

The trade routes began in the Rhone Valley in southern France and the longest of them ended in China. The Jewish traders and bankers acted as middlemen between Christians and Muslims.

The system of letters of credit and bills of exchange was developed by these Jews to replace the heavy coins.

As a result, Jewish enclaves of traders and bankers were established in many nations, including China. They were protected by the national governments because they were beneficial to the local economies but heavy persecution was applied to poor Jewish people.

THE KHAZARS

The Khazars were a group of people that were a mixture of Turks, Persians and Mongols. This group of people had conquered the land located between the Black Sea and the Caspian Sea Around by 600 A.D. High mountain ranges shielded them in the south from the Islamic armies and its capital of Ityl was located at the mouth of the river Volga.

The emperor of the Khazars and his court converted to Judaism around 700 A.D. and a decree was issued that all citizens of Khazaria should convert to Judaism as well. Jewish rabbis were brought in to set up synagogues and teach the population Jewish customs which included the Cabala, Talmud and the Old Testament to some degree. When the Khazar empire broke up some 330 years later, they were considered the “thirteenth tribe.” Khazar Jews were forced to flee north into Russia and west into Poland and other east European nations by invading armies. Therefore, millions of Jews from Russia and Eastern Europe are not true descendants of Abraham but Gentiles who converted to Judaism. A large portion of American Jews descended from the Khazars.⁶

CONSOLIDATING POWER

From having been a decentralized network of Jewish traders and bankers, the Cabalistic leadership started the next step to take over the world. They selected a man from Germany by the name of Hans Fugger⁷ in 1367 to develop a prototype of the banking and trading dynasty.

This information about the Fuggers is never taught in history classes since it is damaging information to the World Government.

The Cabalistic leadership had access to the wealth accumulated by Jewish traders and bankers and it did not take long for the Fugger family to have access to large sums of money that they gave enormous loans to Emperors Maximilian I and Charles V of the Holy Roman Empire. This gave rise to the Roman Catholic Church selling indulgence or forgiveness of sin to those who could afford it and these transactions were handled by the Fugger family who leased the Roman Mint in Rome from the years 1508-1515. This gave the Fugger's control of the economy of the Roman Catholic Church for that period of time.

When the King of Spain needed money to finance the voyage of Christopher Columbus, it was the Fugger family that loaned the money, and it was repaid in gold and silver that the Spanish stole from the Indians in South America.

Both Ferdinand I and Phillip II of Spain became heavily indebted to the Fugger family and granted them mining rights in Chile and Peru. The Fuggers also invested in the slave trade from Africa to the Americas.

In 1516 the Fugger family granted huge loans to King Henry VIII of England, which gave the family access to that nation.

But in time the Fugger family disintegrated and through mismanagement a huge portion of their wealth was lost and by 1550 the power of this family was waning. The Cabalistic leadership had learned that there must be a succession that is controlled when building a wealthy family with which to control kings. As the Fugger family grew over the years, there was no central leadership left and the different branches of the family did not toe the political line set forth by the Cabalistic leadership.

The Rothschild family was selected 214 years later in 1764 to be the family that would bring financial control over the whole world.
