### **PART 4: THE ROOT OF ALL EVIL**

The earth belongs to the Lord and that means that all things existing on this planet such as the land, water and air. This includes mankind, land animals, fish in the oceans and lakes, birds in the skies, along with all the gold, silver, diamonds, coal and oil found under the surface of the earth.

When a human being is conceived in the womb, he is loaned a physical body that must be returned to the owner of the earth after a maximum time of 120 years. **Genesis 6:3**

#### **MAN OWNED NOTHING – BUT TOOK IT ALL**

When Adam and Eve sinned, their spirits died and their souls were contaminated with a sinful nature, which is passed on to every baby born on this earth. **Romans 5:12-14**

Man was told to subdue the earth and manage what God created. **Genesis 1:26-27**

After the fall of Adam and Eve, God divided up the earth for the sons of Adam and gave them specific areas in which to live and work. **Deuteronomy 32:8**

During the 1,676 years before the Flood, greed and lust for power corrupted the people and mankind began to murder in order to take control of more land. Local war lords came into existence and war raged between rival groups. **Genesis 6:11**

The people living before the Flood disregarded the fact that God had loaned them the land, instead, they acted as if they were the owners, and there was more murder and war in their greed to control and own more land.

Since the people refused to acknowledge God and obey their landlord, He had no choice but to evict them; only Noah and his three sons and their wives found grace in the eyes of the Lord.

#### **THE INVENTION OF MONEY**

Through archeology we know that society before the Flood had reached a level of sophistication. Bartering is used in a primitive society to trade goods but the people living prior to the Flood had developed a currency that was used to pay for manufactured items and food and services rendered. A government had been established and land was sold to individuals and the deeds of the properties were recorded by government agencies. The money consisted of minted gold and silver coins. In order for a currency to have a value, government and people must agree to accept the value of a currency and use it to pay for food, clothing, tools, weapons, taxes, etc. Once this has been established, whoever controls the issuing of the currency will also control the nation.

This should not come as a surprise to Christians since Lucifer had been the ruler of the earth prior to his rebellion when he built up a civilization of cities, nations and commerce. **Isaiah 14:12-17; Ezekiel 28:14-19**



This knowledge of government, trade, currency, etc. was transferred by the fallen angels that mingled with women prior to the Flood. **Genesis 6:1-4**

## **LIFE AFTER THE FLOOD**

God divided up the land on the earth so that people would have the necessary space to build and grow the food they needed. **Genesis 10:1-7**

The three sons of Noah had lived for more than 100 years prior to the Flood and they remembered the society that had existed before the Flood. This knowledge of how to build a society, create a financial system, make tools, weapons, houses, etc. was passed on to their children. This is what happens with children today as they must learn to read and write and have general knowledge of mathematics, science and history in order to get a job when they become adults.

Nimrod was the great grandson of Noah who became the prototype of the future Antichrist. Nimrod had been well educated and used his strength and skill to establish himself as a king. He gathered men of violence and greed and promised them riches if they were willing to make him their king. Once this murdering band had been established, Nimrod started to attack people living around him, taking their land and cattle and turning them into slaves. This is also how Mohammad carved out his Islamic empire some 600 years after Christ and also what Brigham Young did in carving out the Mormon Empire in Utah in 1847.

Nimrod became a dictator and Satan showed him how to consolidate his power to rule and become a tyrant. First, he had an inner core of men who depended upon him for their power. Each of these men was loyal to Nimrod, and in order to have the favor of the tyrant, they were willing to report any inkling of rebellion of the others. This group would later be known as aristocrats and under them was an army whose loyalty was secured by good salaries. Furthermore, each soldier had the right to secure as much loot as he wanted during war time and this included raping women and taking slaves.

Aristocrats became wealthy landowners and employed people to work for them and supervise the slaves doing the hard labor. **Genesis 10:8-10**

God thought otherwise and destroyed this project. **Genesis 11:1-9**

## **GOD'S COUNTERMOVE**

- ❖ A believer in Christ who refuses to tithe is a thief.
- ❖ A believer in Christ who does not tithe will be cursed.
- ❖ A believer in Christ who pays a tithe will be blessed.
- ❖ A believer in Christ who pays his tithe will have the respect of others.

Jesus never abolished the law of tithing. **Matthew 5:17-19; 23:23**

Make sure that you do not tithe to a false ministry. **2 John 7-11**

You are responsible where you plant your tithe. Do not plant it in a ministry where it will be abused and used for personal gain instead of proclaiming the Gospel. **2 Corinthians 11:13-15**

People who are fulltime in the Gospel ministry are mandated by God to be supported by the people to whom they minister. **1 Corinthians 9:14**

This includes apostles, prophets, evangelists, pastors and teachers along with the staff these people are employing to get the Gospel out. **Ephesians 4:11**
